LEGISLATION, REGULATIONS AND POLICY UPDATES

Mr. Dudzic informed of two potential pieces of legislation that may impact the Committee and its duties:

- 1. <u>PA Modernization Act</u> The Maryland Association of Physician Assistants (MdAPA) provided this bill to the Board. The bill would remove many of the supervisory elements from the physician/physician assistant relationship, replace delegation agreements with collaborative agreements and expand the scope of practice for physician assistants.
- 2. <u>General Provisions</u> The Board submitted this proposal following a recommendation in the 2020 sunset. This bill seeks to create a general provisions section in the Maryland Medical Practice Act, which would include all provisions that apply across the board to all professions the Board licenses. Board. While no requirements or standards would change as a result of the bill, if it passes it would require the Committee to develop regulatory changes to align its regulations with the newly reordered statute.
