• FYI - FSMB "Reentry to Practice" Report

Ms. Harris presented an FYI of a current Report by the FSMB Workgroup on Reentry to Practice for state medical and osteopathic boards. The goal of the Report is to update current FSMB policies related to reentry to practice for state medical and osteopathic boards. FSMB has open comments on the Report until February 16, 2024. Board members were directed to submit any questions or comments on the Report to the FSMB.

• FYI - FSMB "Guidelines for the Structure and Function of a State Medical and Osteopathic Board"

Ms. Harris presented an FYI by the FSMB on its triennial review and update of the "Guidelines for the Structure and Function of a State Medical and Osteopathic Board". The goal of the updates is to increase and refine the ability of state medical boards to better protect the health, safety, and welfare of the public. FSMB has open comments on the guidance document until February 16, 2024. Board members were directed to submit any questions or comments on the guidance document to the FSMB.

LEGISLATIVE UPDATE

Mr. Dudzic provided an update to the Board regarding the 2024 legislative session of the Maryland General Assembly. Mr. Dudzic informed the Board that its first hearing on its general provisions proposal was held in the House earlier in the week. Mr. Dudzic also informed the Board that its physician assistant proposal had been withdrawn, and that the Board would instead work off of the Maryland Academy of Physician Assistants bill via the amendment process. Mr. Dudzic updated the Board on other legislation that could have an impact on the Board, including proposals regarding supervised medical graduates, administrative expungements and disclosure of criminal history on license applications.
