
At the request of Ms. Heidi Callahan, PA-C, Ellen Douglas Smith asked the Committee if they would review and accept Ms. Callahan's social work credentials, education, training, and experience and recommend to the Board that she be allowed to practice psychotherapy as a Physician Assistant under the supervision of a Psychiatrist.

After reviewing the information Ms. Callahan submitted, the Committee requested that staff obtain answers to the following questions from her:

1. What does she define as the practice of psychotherapy? What are her duties?
2. What is the scope of practice of the physician who will serve as the primary supervising physician?
3. Is the practice restricted to in/out patient and at a federal facility?
4. What kind of training does she have in psychotherapy as a Clinical Social Worker?
5. What oversight will the psychiatrist have in the prescribing of psychotherapy drugs?
6. What training does she have in prescribing psychotherapy medications?

On a motion made by Dr. Nawaz and seconded by Dr. Raneri, the Committee voted unanimously to adjourn the meeting at 4:33p.m.
