**Daniel R. Alexander, M.D., License #: D52815**

**Area of Practice: Internal Medicine & Clinical Pathology (Glenn Dale, MD)**

**Summary Suspension of August 8, 2012 is Terminated. Suspension for two months.**

**Probation for a minimum of 3 years with terms and conditions.** The Board determined that the physician is guilty of unprofessional conduct in the practice of medicine, found that the physician failed to meet the standard of care and failed to keep adequate medical records in the prescribing of based on the prescribing of high-doses of narcotic medications.
