ORDER TERMINATING PROBATION

On January 5, 2018, Disciplinary Panel A (the “Panel”) of the Maryland State Board of Physicians (the “Board”) and Reginald Biggs, M.D. entered into a Consent Order based on his failure to meet appropriate standards as determined by appropriate peer review for the delivery of quality medical and surgical care. Under the terms and conditions of the Consent Order, Dr. Biggs was reprimanded and placed on probation for one (1) year with certain probationary terms and conditions, including a chart/peer review conducted by the Board or Board disciplinary panel or its agents. Furthermore, the terms and conditions read that an unsatisfactory chart and/or peer review would constitute a violation of the 2018 Consent Order.

On February 11, 2020, upon receiving an unsatisfactory peer review, the Panel and Dr. Biggs entered into a second Consent Order, wherein the Panel concluded as a matter of law that Dr. Biggs failed to meet appropriate standards as determined by appropriate peer review and failed to keep adequate medical records as determined by appropriate peer view. The 2020 Consent Order terminated the probation and probationary terms and conditions of the 2018 Consent Order and suspended Dr. Biggs’ license to practice medicine in Maryland with certain terms and conditions, including that he enrolls in and completes a comprehensive evaluation with the Clinical Assessment Program administered by the Center for Personalized Education for Professionals (“CPEP”) and comply with all evaluations and screening and any educational

intervention recommended as directed by CPEP. The 2020 Consent Order further ordered that Dr. Biggs may petition the Panel to terminate his suspension following CPEP's satisfactory evaluation and their recommendation that he is safe to return to the practice of medicine.

On September 17, 2021, after considering Dr. Biggs petition to terminate his suspension and CPEP opining that he is safe to return to the practice of medicine, the Panel issued an Order Terminating Suspension and Imposing Probation,¹ wherein the Panel terminated the suspension imposed by the 2020 Consent Order and placed Dr. Biggs on probation for a minimum of two (2) years with terms and conditions. Additionally, the Panel ordered that Dr. Biggs be permanently prohibited from treating patients under 18 years old.

Dr. Biggs has satisfactorily complied with all of the terms and conditions of probation and two (2) years have passed.

It is thus, by the Panel, hereby

ORDERED that the probation and probationary terms and conditions imposed by the September 17, 2021 Order Terminating Suspension and Imposing Probation are **TERMINATED**; and it is further

ORDERED that the reprimand imposed by the January 5, 2018 Consent Order remains in effect; and it is further

ORDERED that Dr. Biggs remains permanently prohibited from treating patients under 18 years old in the State of Maryland; and it is further

ORDERED that if there is a presumption that Dr. Biggs has violated the permanent condition, the alleged violation will be adjudicated pursuant to the procedures of a Show Cause Hearing; and it is further
