ORDER TERMINATING PROBATION

On April 4, 2018, Disciplinary Panel A (the "Panel") of the Maryland State Board of Physicians issued an *Amended Order for Summary Suspension of License to Practice Medicine*, summarily suspending Jason E. Goodman, M.D.'s license to practice medicine. On June 14, 2018, the summary suspension was affirmed.

On October 18, 2018, the Panel and Dr. Goodman entered into a Consent Order, wherein the Panel concluded, as a matter of law, that Dr. Goodman was guilty of unprofessional conduct in the practice of medicine, in violation of Health Occ. § 14-404(a)(3)(ii), was addicted to, or habitually abused any narcotic or controlled dangerous substance, as defined in § 5-101 of the Criminal Law Article, in violation of Health Occ. § 14-404(a)(8), and failed to cooperate with a lawful investigation conducted by the Board, in violation of § 14-404(a)(33)¹.

Pursuant to the Consent Order, the summary suspension imposed on April 4, 2018 and affirmed on June 14, 2018 was terminated and Dr. Goodman's license to practice medicine was suspended for a minimum period of eighteen (18) months with the following terms and conditions:

1) pay a civil fine of five thousand dollars (\$5,000.00) within twelve (12) months from the effective date of the Consent Order and 2) enroll and comply with all of the Maryland Professional

Rehabilitation Program's ("MPRP") referrals, rules, and requirements. The Consent Order also provided that after eighteen (18) months, if MPRP determined that Dr. Goodman was safe to practice medicine and complied with the terms of the suspension, Dr. Goodman could petition the Panel to lift the suspension.

On July 22, 2020, Dr. Goodman filed a Petition to Terminate Suspension ("Petition"). Dr. Goodman paid the civil fine, and MPRP provided a written update to the Panel stating that Dr. Goodman complied with MPRP's recommendations and that he is safe to return to the practice of medicine with certain terms and conditions. On October 23, 2020, after consideration of the Dr. Goodman's Petition, the Panel issued an *Order Terminating Suspension and Imposing Probation*, wherein the suspension imposed by the October 18, 2018 Consent Order was terminated, and Dr. Goodman was placed on probation for a minimum period of five (5) years, ordered to continue his enrollment with MPRP, and required to comply with five (5) permanent conditions on his license to practice medicine.

Dr. Goodman has fully and satisfactorily complied with the probation and terms and conditions imposed by the October 23, 2020, *Order Terminating Suspension and Imposing Probation*, and five (5) years have passed.

It is thus, by the Panel, hereby

ORDERED that the probation and probationary terms and conditions imposed by the October 23, 2020, *Order Terminating Suspension and Imposing Probation* are **TERMINATED**; and it is further

ORDERED that the permanent conditions imposed by the October 23, 2020, *Order Terminating Suspension and Imposing Probation* remain in effect; and it is further

ORDERED that Dr. Goodman is PERMANENTLY PROHIBITED from practicing medicine as a solo practitioner², conducting house calls, practicing medicine in a concierge practice, prescribing and dispensing all Controlled Dangerous Substances (CDS), and certifying patients for medical use of cannabis, and it is further

ORDERED that, for as long as he holds a Maryland medical license, Dr. Goodman shall provide an annual affidavit on every January 31st thereafter verifying the following: he has not practiced medicine as a solo practitioner, he has not conducted house calls, he has not practiced medicine in a concierge practice, he has not prescribed or dispensed any CDS, and he has not certified patients for Cannabis in the past year; and it is further

ORDERED that if Dr. Goodman fails to provide the required annual verification of compliance:

- 1. This will be construed that Dr. Goodman has violated the permanent condition; and
- That the alleged violation will be adjudicated pursuant to the procedures of a Show
 Cause Hearing; and it is further

ORDERED that this is a public document.
