CONSENT ORDER

The Maryland State Board of Physicians (the "Board") and the Respondent, Ife Rodney, M.D., agree to enter into this Consent Order in order to resolve Dr. Rodney's dispensing prescription medication without a permit issued by the Board.

FINDINGS OF FACT

On August 16, 2020, the Board issued Dr. Rodney a permit to dispense prescription medication in Maryland. The dispensing permit had an expiration date of August 15, 2023. However, H.O. 12-102(c)(2)(ii)4L requires a permit holder annually report to the respective board of licensure whether the physician has personally prepared and dispensed prescription drugs within the previous year. Notices of the Annual Report for Physician's Permit to Dispense Prescription Drugs were sent to Dr. Rodney on June 18, 2020, July 16, 2020 and August 6, 2020. Each Notice advised Dr. Rodney that failure to provide the report may result in the lapse of the dispensing permit. The authorization for Dr. Rodney to dispense prescription medication lapsed on August 16, 2020. Dr. Rodney responded to the June 18, 2020 Annual Report on September 18, 2020. After the lapse of the dispensing permit issued on August 16, 2020, Dr. Rodney continued to dispense prescription medication in Maryland, although she did not have a permit to do so.

CONCLUSION OF LAW

Based upon the findings of fact, Disciplinary Panel A concludes that Dr. Rodney failed to comply with § 12-102 of the Health Occupations Article, in violation of § 14-404(a)(28) of the Health Occupations Article. Section 12-102 of the Health Occupations Article requires that a physician dispensing prescription medication or devices has a permit issued by the Board. *See* Health Occ. § 12-102(c)(2)(ii)1.C.

ORDER

It is thus, by Panel A, hereby:

ORDERED that, within 90 days, Dr. Rodney shall pay a civil fine of \$1500 (One Thousand Five Hundred Dollars) by bank certified check or money order made payable to the Maryland Board of Physicians, P.O. Box 37217, Baltimore, Maryland 21297; and it is further

ORDERED that the effective date of the Consent Order is the date the Consent Order is signed by the Executive Director of the Board or her designee. The Executive Director or her designee signs the Consent Order on behalf of the disciplinary panel which has imposed the terms and conditions of this Consent Order; and be it further

ORDERED that if Dr. Rodney allegedly fails to comply with any term or condition imposed by this Consent Order, the Respondent shall be given notice and an opportunity for a hearing. If the disciplinary panel determines that there is a genuine dispute as to material fact, the hearing shall be before an Administrative Law Judge of the Office of Administrative Hearings followed by an exceptions process before a disciplinary panel; and if the disciplinary panel determines there is no genuine dispute as to a material fact, the Respondent shall be given a show cause hearing before a disciplinary panel; and it is further

ORDERED that, after the appropriate hearing, if the disciplinary panel determines that the Respondent has failed to comply with any term or condition imposed by this Consent Order, the disciplinary panel may reprimand the Respondent, place the Respondent on probation with appropriate terms and conditions, or revoke the Respondent's license. The disciplinary panel may, in addition, to one or more of the sanctions set forth above, impose an additional civil monetary fine on the Respondent; and be it further

ORDERED that this is a public document.

I voluntarily enter into and agree to comply with the terms and conditions set forth in the Consent Order. I waive any right to contest the Findings of Fact and Conclusions of Law and Order set out in the Consent Order. I waive all rights to appeal this Consent Order.

I sign this Consent Order, without reservation, and fully understand the language and meaning of its terms.
