## ORDER TERMINATING PROBATION

On July 13, 2022, Disciplinary Panel B (the "Panel") of the Maryland State Board of Physicians (the "Board") issued an Order for Summary Suspension of License to Practice Medicine. wherein the Panel summarily suspended Asheesh Kumar, M.D.'s Maryland medical license. On July 28, 2022, the summary suspension was affirmed.

On October 21, 2022, the Panel and Dr. Kumar entered into a Consent Order wherein the Panel concluded, as a matter of law, that Dr. Kumar was guilty of unprofessional conduct in the practice of medicine; in violation of Health Occ. § 14-404(a)(3)(ii); was professionally, physically, or mentally incompetent, in violation of Health Occ. § 14-404(a)(4); and provided professional services while under the influence of alcohol, in violation of Health Occ. § 14-404(a)(9)(i).

Under the terms of the Consent Order, the Panel terminated the June 13, 2022 Order of Summary Suspension and July 28, 2022 affirmation as moot, reprimanded Dr. Kumar, and suspended him for a minimum period of six (6) months with terms and conditions, including that he enrolls in the Maryland Professional Rehabilitation Program ("MPRP") and successfully complete a course in professionalism. The Consent Order further ordered that Dr. Kumar may submit a written petition to the Panel to terminate the suspension once he complied with its terms and conditions and MPRP determined that he is safe to return to the practice of medicine.

On May 1, 2023, after consideration of Dr. Kumar's petition to terminate his suspension and MPRP's recommendation that Dr. Kumar was safe to return to the practice of medicine, the Panel issued an Order Terminating Suspension and Imposing Probation<sup>1</sup> terminating the suspension imposed by the October 21, 2022 Consent Order and ordered that Dr. Kumar be placed on probation for a minimum period of two (2) years with terms and conditions, including that he remains in MPRP.

Dr. Kumar has fully and satisfactorily complied with all of the terms and conditions of probation imposed by the May 1, 2023 Order Terminating Suspension and Imposing Probation and two (2) years have passed.

It is thus, by the Panel, hereby

**ORDERED** that the probation and probationary terms and conditions imposed by the May 1, 2023 Order Terminating Suspension and Imposing Probation are **TERMINATED**; and it is further

**ORDERED** that the reprimand imposed by the October 21, 2022 Consent Order remains in effect; and it is further

**ORDERED** that this is a public document.
