Dear Dr. Moran and Counsel:

On June 11, 2024, Disciplinary Panel B of the Maryland State Board of Physicians issued an **ORDER FOR SUMMARY SUSPENSION OF LICENSE TO PRACTICE MEDICINE**, pursuant to Md. Code Ann., State Gov't § 10-226(c)(2), against Scott C. Moran, M.D. Dr. Moran was given an opportunity for a post-deprivation hearing before Disciplinary Panel B to argue that the order for summary suspension should not be continued. The post-deprivation hearing was scheduled for June 26, 2024. On June 24, 2024, Dr. Moran's attorney sent an email to the Board stating that Dr. Moran waived his right to the post-deprivation hearing. Due to the waiver, Panel B did not hold the post-deprivation hearing; the order for summary suspension, imposed on June 11, 2024, is reaffirmed and continues in effect; and Dr. Moran may request an evidentiary hearing on the merits to appeal the order for summary suspension.

NOTICE OF RIGHT TO APPEAL

Under COMAR 10.32.02.08I, Dr. Moran has the right to request a full evidentiary hearing before an Administrative Law Judge on the order for summary suspension. This request will be granted if the Board receives a written request for a hearing within **TEN** (10) days of the date of this letter. The request for a hearing shall be sent to:

If such a hearing is requested, the regulations require that an Administrative Law Judge set a hearing within 30 days of the request, *see* COMAR 10.32.02.08I, though that 30-day requirement may be waived.

This letter constitutes an order of the Board through Disciplinary Panel B resulting from a formal disciplinary action and is, therefore, a public document.
