ORDER TERMINATING PROBATION

On May 15, 2019, Disciplinary Panel B of the Maryland State Board of Physicians and Amile A. Korangy, M.D. entered into a Consent Order, wherein Panel B found that Dr. Korangy was guilty of unprofessional conduct in the practice of medicine and violated the probation imposed by the June 2, 2014 Order Terminating Suspension and Imposing Probation.¹ Pursuant to the Consent Order, the probation imposed by the June 2, 2014 Order Terminating Suspension and Imposing Probation was terminated and Dr. Korangy was reprimanded and placed on probation anew until he successfully completed a Board disciplinary panel-approved course in prescription writing. The Consent Order also reiterated the permanent conditions from prior orders including a prohibition on practicing pain medicine, a prohibition on prescribing, dispensing, administering, or giving away opioids or benzodiazepines, and a prohibition from Dr. Korangy having any professional association or professional relationship with Atlantic Rehabilitation Services or any health care entity or facility that has a direct or indirect relationship with Michael Korangy or any other family members or relatives of such family members. Dr. Korangy has successfully completed a Board disciplinary panel-approved course in prescription writing. It is thus hereby

ORDERED that the probation imposed by the May 15, 2019 Consent Order is **TERMINATED**; and it is further

ORDERED that the reprimand remains in effect; and it is further

ORDERED that the permanent condition prohibiting Dr. Korangy from practicing pain medicine/pain management remains in effect; and it is further

ORDERED that the permanent condition prohibiting Dr. Korangy from prescribing, dispensing, administering, or giving away and opioid or benzodiazepine medicine to any patient or individual remains in effect; and it is further

ORDERED that the permanent condition prohibiting Dr. Korangy from having any professional association or professional relationship with, or provide any medical/surgical services on behalf of, Atlantic Rehabilitation Services or any health care entity or facility that has a direct or indirect relationship with Michael Korangy or any other family members or relatives of such family members remains in effect; and it is further

ORDERED that this is a public document.
