CONSENT ORDER

PROCEDURAL BACKGROUND

The Maryland Board of Physicians (the “Maryland Board”) received information that Melinda Jo Wolf, M.D., (the “Respondent”) License Number D33129, was disciplined by the Colorado Medical Board (the “Colorado Board”) by Letter of Admonition dated June 8, 2021.

Based on the above referenced Colorado Board sanction, the Maryland Board has grounds to charge the Respondent with violating the following provisions of the Maryland Medical Practice Act (the “Act”), under H. O. § 14-404(a):

- (a) Subject to the hearing provisions of § 14-405 of this subtitle, a disciplinary panel, on the affirmative vote of a majority of the quorum of the disciplinary panel, may reprimand any licensee, place any licensee on probation, or suspend or revoke a license if the licensee:
 - (21) Is disciplined by a licensing or disciplinary authority or convicted or disciplined by a court of any state or country or disciplined by any branch of the United States uniformed services or the Veteran’s Administration for an act that would be grounds for disciplinary action under this section,

Disciplinary Panel A (“Panel A”) has determined that the acts for which the Respondent was disciplined in Colorado would be grounds for disciplinary action under

H.O. § 14-404(a). The grounds for disciplinary action under H.O. § 14-404(a) are as follows:

(3) Is guilty of:

(ii) Unprofessional conduct in the practice of medicine.

Based on the action taken by the Colorado Board, the Respondent agrees to enter into this Consent Order with Panel A, consisting of Procedural Background, Findings of Fact, Conclusions of Law, Order and Consent.

FINDINGS OF FACT

Panel A makes the following findings of fact:

1. At all times relevant hereto, the Respondent was a physician licensed to practice medicine in the State of Maryland. The Respondent was initially licensed in Maryland on or about December 18, 1985.

2. By Letter of Admonition dated June 8, 2021, the Colorado Board found that the Respondent committed unprofessional conduct when she did not make efforts to ensure that a patient followed up with the VA for additional evaluations regarding the patient's elevated PSA and did not conduct additional testing or refer the patient to a urologist.

A copy of the June 8, 2021 Letter of Admonition is attached hereto.

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, Panel A concludes as a matter of law that the Respondent is subject to discipline under Health Occ. § 14-404(a)(21) for the disciplinary action taken by the Colorado Board against the Respondent for an act or acts that would be grounds for disciplinary action under Health Occ. §14-404(a)(3)(ii).

ORDER

It is, thus, by Panel A, hereby:

ORDERED that the Respondent be and is hereby **REPRIMANDED**; and it is further

ORDERED that the effective date of the Consent Order is the date the Consent Order is signed by the Executive Director of the Board or her designee; and it is further

ORDERED that this Consent Order is a public document. *See* Health Occ. §§1-607, 14-411.1(b)(2) and Gen. Prov. §4-333(b)(6).

jurisdiction of the disciplinary panel to initiate these proceedings and to issue and enforce this Consent Order.

I voluntarily enter into and agree to comply with the terms and conditions set forth in the Consent Order as a resolution of the charges. I waive any right to contest the Findings of Fact and Conclusions of Law and Order set out in the Consent Order. I waive all rights to appeal this Consent Order.

I sign this Consent Order, without reservation, and fully understand the language and meaning of its terms.

Dear Dr. Wolf,

The Colorado Medical Board has concluded its inquiry into the aforementioned matter. It was the Panel's decision not to commence with formal proceedings against your professional license. However, the Panel did determine disciplinary action in the form of this letter of admonition is warranted.

As you recall, on April 11, 2013, you treated Patient A as his primary care physician at a Colorado Veteran's Affairs facility ("VA"). Patient A was a 61-year-old male with adult-onset diabetes, hyperlipidemia, coronary artery disease and obesity. You ordered laboratory testing, including a check of Patient A's prostate-specific antigen ("PSA"). The lab testing revealed that Patient A had an elevated PSA level of 10.16. Patient A later called to obtain the results of his lab work. The triage nurse who took Patient A's call told Patient A about some of the lab results, but did not inform him about the elevated PSA. Instead, the nurse made a note of the elevated PSA in the medical record and also told Patient A that she would tell you that he called for his lab results. On May 9, 2013, you signed off on the nurse's message. However, you did not call Patient A to discuss his elevated PSA level. Patient A did not make a follow up appointment as instructed.

After reviewing the information in this case, the Panel finds that you committed unprofessional conduct, in violation of section 12-240-121(1)(j) of the Colorado Revised Statutes. Specifically, you did not inform Patient A of his elevated PSA level. Because you did not make efforts to ensure that Patient A followed up with the VA for additional evaluations, you also did not conduct additional testing or refer Patient A to a urologist.

By this letter, the Board takes the formal disciplinary action of admonishing you for the conduct specified above, and warns you that repetition of such practice may lead to imposition of more severe disciplinary action. This letter is an open public record and a reportable action to individuals or entities requesting disciplinary information. The Board strongly encourages you to review and understand the Medical Practice Act requirements and obligations for the practice of medicine in Colorado.


In accordance with 12-20-404(4)(b), the Board advises you that you have the right to make a written request that the Board initiate formal disciplinary proceedings in order to adjudicate the conduct or acts upon which this letter is based. You must make your written request within twenty (20) days after receipt of this letter and address your request to Paula E. Martinez, Program Director, at the email address listed below. If you make a timely request, the Board will deem this letter of admonition vacated and may proceed with disciplinary and/or injunctive proceedings in accordance with 12-20-404(4)(b)(II), C.R.S., and applicable rules.

A Letter of Admonition, when accepted, becomes a permanent, public portion of your record. It is not, however, a restriction on your practice as a professional physician.
