Dear Dr. Quon and Counsel:

On March 26, 2019, Disciplinary Panel A of the Maryland State Board of Physicians issued an **ORDER OF SUMMARY SUSPENSION OF LICENSE TO PRACTICE MEDICINE** in this case, pursuant to Md. Code Ann., State Gov't § 10-226(c)(2)(i) (2014 Repl. Vol. & 2018 Supp.). Dr. Quon was given an opportunity to attend a post-deprivation hearing before Disciplinary Panel A to show cause why that suspension should not be continued on April 10, 2019. Dr. Quon did not attend the hearing, but he was represented by counsel, Kenneth West. The State was represented by Christopher Anderson, Administrative Prosecutor. At the hearing, Mr. West, on behalf of Dr. Quon, stated that Dr. Quon consented to the summary suspension, and therefore, neither party presented any arguments in opposition to the continuance of the summary suspension.

After considering the presentations of the parties at the hearing and the investigative file, Disciplinary Panel A determined that it would continue the summary suspension imposed on March 26, 2019. The order of summary suspension is thus reaffirmed and will continue. COMAR 10.32.02.08H(1). Disciplinary Panel A, through its counsel, advised the parties of this decision orally on the hearing date.

NOTICE OF RIGHT TO APPEAL

Under the Board's regulations, Dr. Quon has the right to request a full evidentiary hearing before an Administrative Law Judge. This request will be granted if the Board receives



a written request for a hearing within **TEN (10)** days of the date of this letter. Any request for a hearing should be sent to Christine A. Farrelly, Executive Director, at the Board's address. If such a hearing is requested, the regulations require that an Administrative Law Judge set the hearing to begin within 30 days of the request, *see* COMAR 10.32.02.08 I, though that 30-day requirement may be waived.

This letter constitutes an order of the Board through Disciplinary Panel A resulting from formal disciplinary action and is therefore a public document.
