Dear Dr. Oyler and Counsel:

On August 11, 2022, Disciplinary Panel B of the Maryland State Board of Physicians issued George A. Oyler, M.D., License Number D46921, an **ORDER FOR SUMMARY SUSPENSION OF LICENSE TO PRACTICE MEDICINE** in this case, pursuant to Md. Code Ann., State Gov't § 10-226(c)(2). Under § 10-226(c)(2)(ii)2, after an order for summary suspension is issued, the agency shall promptly give the subject of the order an opportunity to be heard. Thus, the Board scheduled a post-deprivation hearing in this matter for August 24, 2022, before Panel B. However, on August 23, 2022, counsel for Dr. Oyler notified the Board that Dr. Oyler waived his right to the post-deprivation hearing, that Dr. Oyler was in agreement with the continuation of the order for summary suspension at this time, and that the hearing did not need to remain on the panel's agenda. Therefore, Panel B will not terminate the order for summary suspension at this time, and the order for summary suspension, imposed on August 11, 2022, is reaffirmed and continues in effect.

NOTICE OF RIGHT TO APPEAL

Under COMAR 10.32.02.08I, Dr. Oyler has the right to request a full evidentiary hearing before an Administrative Law Judge at the Office of Administrative Hearings. This request will be granted if the Board receives a written request for the hearing within **TEN** (10) days of the date of this order. Any request for a hearing should be sent to Christine A. Farrelly, Executive Director, at 4201 Patterson Avenue, Fourth Floor, Baltimore, Maryland 21215. If Dr. Oyler requests such a hearing, an Administrative Law Judge shall set the hearing to begin within 30 days of the request, *see* COMAR 10.32.02.08I, though Dr. Oyler may waive the 30-day requirement.

This letter constitutes an order of Disciplinary Panel B resulting from a formal disciplinary action and is, therefore, a public document.
