ORDER TERMINATING PROBATION

On April 30, 2018, Disciplinary Panel A of the Maryland State Board of Physicians and Daniel B. Levy, M.D., entered into a Consent Order, wherein Panel A found that Dr. Levy had failed to meet appropriate standards as determined by appropriate peer review for the delivery of quality medical care and had violated Conditions 6 and 7 of the Consent Order dated May 23, 2016. Pursuant to the April 2018 Consent Order, the probation and probationary conditions imposed by the May 2016 Consent Order were terminated, Dr. Levy was reprimanded, placed on probation for a minimum of eighteen (18) months with certain terms and conditions, required to cease the practice of chronic pain management, and was permanently prohibited from prescribing any opioids to any patient for more than three (3) days and only in an emergency situation. Additionally, emergency opioid prescriptions written by Dr. Levy may not exceed the lowest effective dose and quantity for a duration of three (3) days, may not be refilled or renewed, and must be reported to the Board by Dr. Levy within twenty four (24) hours of being written. Dr. Levy has fully and satisfactorily complied with all of the terms and conditions of the probation imposed by the April 30, 2018 Consent Order. It is thus hereby

ORDERED that the probation imposed by the April 30, 2018 Consent Order is **TERMINATED**; and it is further

ORDERED that the reprimand imposed by the April 30, 2018 Consent Order remains in effect; and it is further

ORDERED that the permanent prohibitions from practicing chronic pain management and from prescribing opioids to any patient for more than three (3) days and only in an emergency situation remain in effect; and it is further

ORDERED that in emergency cases, Dr. Levy may not prescribe opioids exceeding the lowest effective dose and quantity needed for a duration of three (3) days. These prescriptions may not be refilled, nor may they be renewed. Dr. Levy shall notify the Board within twenty-four (24) hours of any prescription written under the authority of this paragraph; and it is further

ORDERED that the Panel may issue administrative subpoenas to the Maryland Prescription Drug Monitoring Program on a quarterly basis to ensure that Dr. Levy is in compliance with the terms and conditions of this Order, and it is further

ORDERED that this is a public document.
