CONSENT ORDER

PROCEDURAL BACKGROUND

On December 7, 2016, Disciplinary Panel A ("Panel A") of the Maryland State Board of Physicians (the "Board") voted to charge **LISA R. GINN, M.D.** (the "Respondent"), License Number D61809, with violating the Maryland Medical Practice Act (the "Act"), Md. Code Ann., Health Occ. II ("Health Occ. II") §§ 14-101 *et seq.* (2014 Repl. Vol.).

Specifically, Panel A voted to charge the Respondent with violating the following provision of the Act under Health Occ. II § 14-404:

- (a) In general. -- Subject to the hearing provisions of § 14-405 of this subtitle, a disciplinary panel, on the affirmative vote of a majority of the quorum of the disciplinary panel, may reprimand any licensee, place any licensee on probation, or suspended or revoke a license if the licensee:
 - (28) Fails to comply with the provisions of § 12-102 of this article[.]

Md. Health Occ. II § 12-102 provides:

...

- (c) Preparing of prescriptions by licensed dentist, veterinarian, physician, etc.; exception:
 - (2) This title does not prohibit:

- (ii) A licensed dentist, physician, or podiatrist from personally preparing and dispensing the dentist's, physician's, or podiatrist's prescriptions when:
 - 1. The dentist, physician, or podiatrist:

...

- A. Has applied to the board of licensure in this State which licensed the dentist, physician, or podiatrist;
- C. Has received a written permit from that board to dispense prescription drugs or devices except that a written permit is not required in order to dispense starter dosages or samples with charge[.]

Prior to the issuance of charges, the Respondent agreed to enter into this public Consent Order, consisting of Procedural Background, Findings of Fact, Conclusions of Law, Order, Consent and Notary.

FINDINGS OF FACT

Panel A of the Board makes the following Findings of Fact:

- 1. At all times relevant hereto, the Respondent was and is licensed to practice medicine in the State of Maryland. The Respondent was initially licensed to practice medicine in Maryland on or about May 28, 2004, under License Number D61809. The Respondent's license is active and current through September 30, 2018.
- 2. The Respondent is board-certified in dermatology and at all times relevant hereto, maintained a medical office in Chevy Chase, Maryland.
- 3. On or about June 18, 2010, the Board issued the Respondent a dispensing permit under permit # 2293. On or about June 17, 2015, the Respondent's dispensing permit expired. The Respondent did not submit a renewal application for her dispensing permit at that time.

- 4. On or about May 17, 2016, the Respondent submitted an application to the Board to renew her dispensing permit, which the Board issued, effective June 17, 2016.
- 5. The Board initiated an investigation of the Respondent after reviewing her May 17, 2016, dispensing permit renewal application, in which it noted that her dispensing permit had expired in 2015. In a letter to the Respondent dated July 25, 2016, Board staff requested that she explain why she filed a late renewal application.
- 6. In a letter to the Board dated August 1, 2016, the Respondent acknowledged that she failed to renew her dispensing permit when it expired on June 17, 2015, stating that she mistakenly thought that her permit expired in June 2016. The Respondent stated that her dispensing was confined to the drug tretinoin, a non-controlled, non-narcotic prescription medication, which she dispensed as a topical cream in standard strengths on a limited basis to patients for dermatologic purposes. The Respondent acknowledged that after her permit expired, she continued to dispense tretinoin until on or about May 23, 2016. The Respondent stated that after she realized that her permit had expired, she ceased dispensing all prescription medications from her office until the Board renewed her dispensing permit.
- 7. The Board's investigation determined that the Respondent dispensed prescription medications from her office after her dispensing permit expired on June 17, 2015, and that she continued to do so until on or about May 23, 2016, in violation of Health Occ. II §§ 14-404(a)(28).

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, Panel A concludes as a matter of law that the Respondent violated the following provision of the Act: Health Occ. II § 14-404(a)(28), Fails to comply with the provisions of § 12-102 of this article.

<u>ORDER</u>

It is, on the affirmative vote of a majority of the quorum of Panel A, hereby:

ORDERED that the Respondent is REPRIMANDED; and it is further

ORDERED that within SIX (6) MONTHS, the Respondent shall pay a civil fine in the amount of ONE THOUSAND AND FIFTY DOLLARS (\$1,050.00), by money order or bank certified check, made payable to the Maryland Board of Physicians, P.O. Box 37217, Baltimore, Maryland 21297; and it is further

ORDERED that the Consent Order goes into effect upon the signature of the Board's Executive Director, who signs on behalf of Panel A; and it is further

ORDERED that if the Board or Panel A determines, after notice and an opportunity for a hearing before an Administrative Law Judge of the Office of Administrative Hearings if there is a genuine dispute as to a material fact or a show cause hearing before the Board or Panel A if there is no genuine dispute as to a material fact, that the Respondent has failed to comply with any term or condition of this Consent Order, the Board or Panel A may reprimand the Respondent, place the Respondent on probation with appropriate terms and conditions, or suspend or revoke the Respondent's license to practice medicine in Maryland. The Board or Panel A may, in addition to one or more of the sanctions set forth above, impose a civil monetary fine upon the Respondent; and it is further

ORDERED that this Consent Order is a PUBLIC DOCUMENT pursuant to Md. Code Ann., Gen. Provisions §§ 4-101 *et seq.* (2014).
