#### **CONSENT ORDER**

On October 11, 2022, Disciplinary Panel A ("Panel A") of the Maryland State Board of Physicians (the "Board") charged JENNIFER ADU-FRIMPONG, M.D. (the "Respondent"), License Number D69764, under the Maryland Medical Practice Act (the "Act"), Md. Code Ann., Health Occ. ("Health Occ.") §§ 14-101 et seq. (2021 Repl. Vol.). Specifically, Disciplinary Panel A charged the Respondent with violating the following provisions of the Act:

- § 14-404. Denials, reprimands, probations, suspensions, and revocations Grounds.
- (a) In general. Subject to the hearing provisions of § 14-405 of this subtitle, a disciplinary panel, on the affirmative vote of a majority of the quorum of the disciplinary panel, may reprimand any licensee, place any licensee on probation, or suspend or revoke a license if the licensee:
  - (3) Is guilty of: (ii) Unprofessional conduct in the practice of medicine; and/or

(28) Fails to comply with the provisions of § 12-102 of this article[.]

On December 7, 2022, Panel A was convened as a Disciplinary Committee for Case Resolution ("DCCR") in this matter. Based on negotiations occurring as a result of this DCCR, the Respondent agreed \to enter into this Consent Order, consisting of Findings of Fact, Conclusions of Law, Order, and Consent.

#### **FINDINGS OF FACT**

Disciplinary Panel A finds:

- 1. At all relevant times, the Respondent was and is licensed to practice medicine in the State of Maryland. The Board initially issued the Respondent a license to practice medicine in Maryland on September 14, 2009, under License Number D69764. Her license is scheduled to expire on September 30, 2024.
- 2. The Respondent is board certified in Pediatrics and Pediatric Emergency Medicine and at all relevant times practiced at an urgent care center with offices in Bel Air and Westminster, Maryland.
- 3. On October 30, 2020, the Board issued a permit to the Respondent to dispense prescription drugs under Permit #4191.
- 4. The Board sent notices to the Respondent regarding the Annual Report for Physician's Permit to Dispense Prescription Drugs<sup>1</sup> on the following dates: September 9,

<sup>&</sup>lt;sup>1</sup> Doctors who hold a permit to dispense prescription medication in Maryland are required to annually report to the respective board of licensure whether the physician has personally prepared and dispensed prescription drugs within the previous year. See: Health Occupations § 12-102(c)(2)(ii)(4)(L).

2021, October 7, 2021, and October 28, 2021. The Respondent failed to respond to the Board's correspondence.

5. On November 21, 2021, the Respondent's permit expired.

### **Board Investigation**

- 6. On April 5, 2022, the Board notified the Respondent that it had opened an investigation of her after receiving information that the Respondent or her physician assistant(s) had continued to dispense medications after the expiration of the Respondent's license. The Board also issued a subpoena to the Respondent requesting a complete copy of the Respondent's logs for medication dispensed and/or delegated during the period of November 22, 2021 through April 5, 2022.
- 7. The Board received the dispensing logs requested from the Respondent which indicated that the Respondent and/or her delegates had dispensed a series of pediatric medications after the expiration of her permit in November 2021 through April 2022.

## Respondent's Written Response

8. On June 13, 2022, the Respondent, through counsel, submitted a written response to the allegations. The Respondent stated that she became aware that her permit had expired in December 2021 and that she never received the notices from the Board. She made attempts to contact the Board after she realized her permit had expired but did not receive a response from the Board until April 2022 due to a technology incident involving the Board's system. The Respondent was granted a new permit on May 6, 2022.

#### **CONCLUSIONS OF LAW**

Based on the foregoing findings of fact, Disciplinary Panel A concludes as a matter of law that the Respondent is guilty of unprofessional conduct in the practice of medicine, in violation of Health Occ. § 14-404(a)(3)(ii); and failing to comply with the provisions of § 12-102 of this article, in violation of Health Occ. § 14-404(a)(28).

#### <u>ORDER</u>

It is, on the affirmative vote of a majority of the quorum of Disciplinary Panel A of the Board, hereby:

ORDERED that the Respondent is REPRIMANDED; and it is further

ORDERED that within ONE (1) YEAR of the effective date of this Consent Order, the Respondent shall pay a civil fine of FIFTEEN HUNDRED DOLLARS (\$1, 500.00). The Payment shall be by money order or bank certified check made payable to the Maryland Board of Physicians and mailed to P.O. Box 37217, Baltimore, Maryland 21297. The Board will not renew or reinstate the Respondent's license if the Respondent fails to timely pay the fine to the Board; and it is further

ORDERED that the effective date of the Consent Order is the date the Consent Order is signed by the Executive Director of the Board or her designee. The Executive Director signs the Consent Order on behalf of the disciplinary panel which has imposed the terms and conditions of this Consent Order; and it is further

ORDERED that the Respondent is responsible for all costs incurred in fulfilling the terms and conditions of this Consent Order; and it is further

ORDERED that this Consent Order is a public document. See Md. Code Ann.,

Health Occ. §§ 1-607, 14-411.1(b)(2) and Gen. Prov. § 4-333(b)(6).
