# CONSENT ORDER

The Maryland State Board of Physicians (the "Board") and the Respondent Tejaswi Sastry, M.D. agree to enter into this Consent Order in order to resolve Dr. Sastry's dispensing prescription medication without a permit issued by the Board.

# FINDINGS OF FACT

On May 11, 2017, the Board issued Dr. Sastry a permit to dispense prescription medication in Maryland. The dispensing permit had an expiration date of May 10, 2022. On April 27, 2022, Dr. Sastry filed an application with the Board to renew the permit but did not include the applicable fee; thus, the authorization for Dr. Sastry to dispense prescription medication expired on May 10, 2022. After the expiration of the dispensing permit issued on May 11, 2017, Dr. Sastry continued to dispense prescription medication in Maryland, although she did not have a permit to do so. On September 22, 2022, the Board received Dr. Sastry's application for the reinstatement of her dispensing permit with the applicable fee and a new permit was issued.

# **CONCLUSION OF LAW**

Based upon the findings of fact, Disciplinary Panel B concludes that Dr. Sastry failed to comply with § 12-102 of the Health Occupations Article, in violation of § 14-404(a)(28) of the Health Occupations Article. Section 12-102 of the Health Occupations Article requires that a

physician dispensing prescription medication or devices has a permit issued by the Board. See Health Occ. § 12-102(c)(2)(ii)1.C.

#### ORDER

It is thus, by Panel B, hereby:

**ORDERED** that, within 90 days, Dr. Sastry shall pay a civil fine of \$1000.00 by bank certified check or money order made payable to the Maryland Board of Physicians, P.O. Box 37217, Baltimore, Maryland 21297; and it is further

**ORDERED** that the effective date of the Consent Order is the date the Consent Order is signed by the Executive Director of the Board or her designee. The Executive Direct30 or her designee signs the Consent Order on behalf of the disciplinary panel which has imposed the terms and conditions of this Consent Order; and be it further

**ORDERED** that if Dr. Sastry allegedly fails to comply with any term or condition imposed by this Consent Order, the Respondent shall be given notice and an opportunity for a hearing. If the disciplinary panel determines that there is a genuine dispute as to material fact, the hearing shall be before an Administrative Law Judge of the Office of Administrative Hearings followed by an exceptions process before a disciplinary panel; and if the disciplinary panel determines there is no genuine dispute as to a material fact, the Respondent shall be given a show cause hearing before a disciplinary panel; and it is further

ORDERED that, after the appropriate hearing, if the disciplinary panel determines that the Respondent has failed to comply with any term or condition imposed by this Consent Order, the disciplinary panel may reprime the Respondent, place the Respondent on probation with appropriate terms and conditions, or revoke the Respondent's license. The disciplinary panel

may, in addition, to one or more of the sanctions set forth above, impose an additional civil monetary fine on the Respondent; and be it further

**ORDERED** that this is a public document.


