# ORDER FOR SUMMARY SUSPENSION OF LICENSE TO PRACTICE MEDICINE

Disciplinary Panel B ("Panel B") of the Maryland State Board of Physicians (the "Board") hereby **SUMMARILY SUSPENDS** the license to practice medicine of **ANGELA GUCWA, M.D.** (the "Respondent"), License Number D78628, in the State of Maryland.

Panel B takes such action pursuant to its authority under Md. Code Ann., State Gov't \$10-226(c)(2)(2022 Repl. Vol.) and Md. Code Regs. ("COMAR") 10.32.02.08B(7), concluding that the public health, safety, or welfare imperatively requires emergency action.

### INVESTIGATIVE FINDINGS

Based on information received by, and made known to Panel B, and the investigatory information obtained by, received by and made known to and available to Panel B, including the instances described below, Panel B has reason to believe that the following facts are true:

#### Introduction

1. Panel B is summarily suspending the Respondent's license to practice medicine after a Board investigation revealed that she has a health condition that affects her ability to practice medicine safely.

## **Background/Licensing Information**

- 2. At all relevant times, the Respondent was licensed to practice medicine in the State of Maryland. The Respondent was originally issued a license to practice medicine in Maryland on October 10, 2014, under License Number D78628. The Respondent's license expires on September 30, 2024, subject to renewal.
  - 3. The Respondent is board-certified in vascular surgery.
- 4. At all relevant times, the Respondent practiced at a hospital<sup>2</sup> (the "Hospital") in Prince George's County, Maryland until July 17, 2023, when the Hospital summarily suspended her clinical privileges after the Respondent attempted to provide medical services while under the influence of alcohol.

# The Report

5. The Board initiated an investigation of the Respondent after receiving a Mandated 10-Day Report (the "Report") from the Hospital on August 1, 2023. The Report stated that the Respondent was "summarily suspended...in accordance with hospital's medical staff bylaws to reduce the substantial likelihood that Dr. Gucwa's exercise of her clinical privileges would create a reasonable possibility of imminent danger to the health

and safety of patients and others at the hospital. The Hospital determined that Dr. Gucwa was intoxicated at work on June 20."

## **Board Investigation**

- 6. The Board subpoenaed and received the Respondent's quality assurance/risk management ("QA/RM") file from the Hospital, employee health file from the Hospital, and treatment records from two health care facilities. The Board also interviewed the Chief Medical Officer of the Hospital and received a written response from the Respondent.
- 7. The investigation determined that on June 20, 2023, the Respondent was intoxicated while at work at the Hospital. On June 20, 2023 at 7:30 a.m., the Respondent was scheduled to perform an interventional radiology procedure in the ambulatory surgery center at the Hospital.
- 8. Staff observed that the Respondent seemed impaired, and instructed her not to perform the procedure. The Respondent was escorted from the surgical suite, and another vascular surgeon was called and provided services to the patient.
- 9. The Respondent was then escorted to employee health unit where she was interviewed and administered a blood alcohol test, which indicated a blood alcohol level of .324 (4 times the legal limit).
- 10. In her written response to the Board, the Respondent admitted she was "in agreement with the facts as stated in the [10 day] report....I am extremely remorseful for my behavior and judgment...."
- 10. On or about August 23, 2023, and with the consent of the Respondent, the Board obtained medical records for the Respondent which document that in July 2023,

the Respondent was diagnosed with and in the process of being treated for certain medical conditions.<sup>3</sup>

### **CONCLUSION OF LAW**

Based upon the foregoing Investigative Findings, Panel B of the Board concludes as a matter of law that the public health, safety, or welfare imperatively requires emergency action, and that pursuant to State Gov't § 10-226(c)(2) and COMAR 10.32.02.08B(7), the Respondent's license is summarily suspended.

#### **ORDER**

**IT IS** thus, by Panel B of the Board, hereby:

**ORDERED** that pursuant to the authority vested in Panel B by State Govt. § 10-226(c)(2)(2022 Repl. Vol.) and COMAR 10.32.02.08B(7), the Respondent's license to practice medicine in the State of Maryland is hereby **SUMMARILY SUSPENDED**; and it is further

**ORDERED** that, during the course of the summary suspension, the Respondent shall not practice medicine in the State of Maryland; and it is further

ORDERED that in accordance with Md. Code Regs. 10.32.02.08B(7) and E, a post-deprivation hearing on the summary suspension will be held on Wednesday, September 27, 2023, at 11:30 a.m. at the Board's offices, located at 4201 Patterson Avenue, Baltimore, Maryland, 21215-0095; and it is further

ORDERED that after the SUMMARY SUSPENSION hearing before Panel B, the Respondent, if dissatisfied with the result of the hearing, may request, within ten (10) days, an evidentiary hearing, such hearing to be set within thirty (30) days of the request, before an Administrative Law Judge at the Office of Administrative Hearings, Administrative Law Building, 11101 Gilroy Road, Hunt Valley, Maryland 21031-1301; and it is further

**ORDERED** that a copy of the Order for Summary Suspension shall be filed by Panel B immediately in accordance with Health Occ. § 14-407 (2022 Repl. Vol.); and it is further

**ORDERED** that this is a disciplinary Order of Panel B, and as such, is a public document. *See* Health Occ. §§ 1-607, 14-411.1(b)(2) and Md. Code Ann., Gen. Prov. § 4-333(b)(6).
