Dear Dr. Aljamal and Counsel:

On October 18, 2023, Disciplinary Panel A of the Maryland State Board of Physicians issued an **ORDER FOR SUMMARY SUSPENSION OF LICENSE TO PRACTICE MEDICINE** in this case, pursuant to Md. Code Ann., State Gov't § 10-226(c)(2) (2022 Repl. Vol.). On October 31, 2023, Dr. Aljamal was given an opportunity to attend a post-deprivation hearing before Disciplinary Panel A to show cause why that suspension should not be continued. Prior to the scheduled hearing, Dr. Aljamal's counsel informed the Board that Dr. Aljamal had decided to waive his right to the post-deprivation hearing and to consent to a continuation of the summary suspension. Due to the waiver, Panel A did not hold a post-deprivation hearing in this matter, the summary suspension continues, and the parties may proceed to the summary suspension appeal if Dr. Aljamal requests an evidentiary hearing as referenced below. COMAR 10.32.02.08E.

NOTICE OF RIGHT TO APPEAL

Under the Board regulations, Dr. Aljamal has the right to request a full evidentiary hearing before an Administrative Law Judge of the Office of Administrative Hearings. This request will be granted if the Board receives a written request for the hearing within **TEN** (10) days of the date of this letter. Any request for a hearing should be sent to Christine A. Maryland Board of Physicians, 4201 Patterson Avenue, Baltimore, Maryland 21215. If such a hearing is requested, the regulations require that an Administrative Law Judge set the hearing to begin within 30 days of the request, *see* COMAR 10.32.02.08I, though the 30-day requirement may be waived.

This letter constitutes an order of the Board through Disciplinary Panel A resulting from formal disciplinary action and is, therefore a public document.
