SECOND VIOLATION OF CEASE AND DESIST ORDER

On September 17, 2021, Disciplinary Panel B (“Panel B” or the “Panel”) of the Maryland State Board of Physicians (the “Board”), pursuant to Health Occupations Article, section 14-206(e)(2), issued a Cease and Desist Order to Dominic L. Diggin, who is unlicensed to practice a health care profession, ordering that he “immediately cease and desist from representing to the public, by title, description of services, methods, procedures, or otherwise, that he is authorized to practice medicine in Maryland, and from using, ‘Dr.’, ‘doctor’, ‘physician’, ‘D.O.’, or ‘M.D.’ with the intent to represent that the Respondent practices medicine.” On July 25, 2024, Panel B issued an Order to Show Cause, charging Mr. Diggin with violating the terms and conditions of the Cease and Desist Order, and scheduled a hearing on the matter for August 28, 2024. On August 23, 2024, Mr. Diggin, through his guardian, requested a postponement of the August 28th hearing to seek legal counsel. On August 26, 2024, the Panel notified Mr. Diggin that his postponement request was granted and that the hearing was rescheduled for October 23, 2024, at 10:30 a.m. On October 15, 2024, Mr. Diggin’s guardian sent an email to the Board stating that she was unable to find an attorney, but that she and Mr. Diggin would be at the hearing unassisted.

On October 23, 2024, Mr. Diggin did not appear at the Show Cause hearing before Panel B. The State appeared and was represented by the administrative prosecutor. The Panel waited until 11:24 am to begin the hearing. On October 23, 2024, at 10:44 p.m., Mr. Diggin’s guardian

sent an email to the Board stating that Mr. Diggin was not in a good place and that he refused to go to the hearing.

FINDINGS OF FACT

Panel B finds that the following factual findings were proven by the preponderance of evidence:

Background

Mr. Diggin has never been licensed to practice medicine in the State of Maryland. He has never been licensed or certified by any health occupations licensing board in Maryland. At all relevant times, Mr. Diggin resided in Maryland.

On May 14, 2021, the Board received a complaint from a health care staffing agency that Mr. Diggin submitted a *curriculum vitae* (“CV”) to the agency representing that he was licensed to practice medicine in Maryland and was board-certified in both internal and emergency medicine. The Board’s investigation further revealed that Mr. Diggin identified himself as a doctor on several social media platforms and websites, including LinkedIn, Quora, and Twitter.

On September 17, 2021, the Board issued a Cease and Desist Order to Mr. Diggin, ordering that he “immediately cease and desist from representing to the public, by title, description of services, methods, procedures, or otherwise, that he is authorized to practice medicine in Maryland, and from using, ‘Dr.’, ‘doctor’, ‘physician’, ‘D.O.’, or ‘M.D.’ with the intent to represent that the Respondent practices medicine.” Mr. Diggin did not oppose the Cease and Desist Order.

Prior Violation of Cease and Desist Order

On or about November 18, 2022, the Board received a complaint (“Complaint 1”) from an attorney¹ for a nationwide teleradiology service company, stating that Mr. Diggin submitted a contact request form stating that he was interested in “radiologist careers” and listed his occupation as “radiologist.” Mr. Diggin submitted a CV of another physician to the company with no substantive change to the CV other than substituting his name in place of the physician’s. The CV listed the Respondent’s name as Dominic Lewis Diggin, MBBS, DNB, (Radiodiagnosis), ECFMG Certified (April 28, 2018). The CV also listed numerous publications purportedly authored by Mr. Diggin, honors and awards, and job experience, all of which was stolen from the CV of the other physician, and none of which were accomplishments of Mr. Diggin.

On or about December 12, 2022, the Board received an email from a healthcare staffing company (“Complaint 2”) stating that it received an inquiry from Mr. Diggin for employment as a physician assistant. Mr. Diggin represented himself as a licensed healthcare provider in reply to an inquiry for a *locum tenens* Emergency Medicine coverage needed in California. He provided the company with a CV that listed his name as Dominic Diggin, PA-C, and noted that he was a “graduate of Pennsylvania College of Technology, PA Program, a National Health Service Corps Scholarship recip[i]ent, and a proud physician assistant with clinical experience in bilingual spanish/english clinical settings.”

The authors of each Complaint researched Mr. Diggin’s qualifications, discovered the Board’s Cease and Desist Order dated September 17, 2021, and immediately notified the Board.

On December 6, 2022, Board staff spoke with a family member (the “Family Member”) of Mr. Diggin who stated that she has guardianship over Mr. Diggin. The Family Member stated that Mr. Diggin is “very obsessed with the medical community...but goes too far.” The Board also received a written response from the Family Member stating that they were “writing this letter with [Mr. Diggin’s] full knowledge and consent.” The letter stated that Mr. Diggin “incorrectly identified himself as a radiologist” and that he “does not represent himself in school as a radiologist nor does he portray one in the community.”

On December 20, 2022, Board staff interviewed Mr. Diggin. During the interview, Mr. Diggin stated that he is 18 years old and began taking classes at a community college in August of 2022. He explained that he found a CV online and used Microsoft Word to remove the doctor’s name and replace it with his own. He stated that he listed his occupation as a radiologist because “that was [his] hope.” He admitted to submitting the CV to the company noted in Complaint 1. He also admitted to making a physician assistant CV because that was one of the careers he was interested in. He stated that he did not recall sending a CV for the physician assistant position as is alleged in Complaint 2. He stated that he received the Cease and Desist Order but did not read it over entirely. He did understand, however, that it meant that he had to “stop doing what [he] was doing.”

On February 23, 2023, Panel B charged Mr. Diggin with violating the terms and conditions of the Cease and Desist Order, dated September 17, 2021. On April 26, 2023, Mr. Diggin appeared at a Show Cause hearing before Panel B. Mr. Diggin admitted to submitting the CV in response to a job advertisement but asserted that he never represented himself as a physician in public and that he created the CV as part of a school assignment. The prosecutor responded that Mr. Diggin did more than just submit the CV to the company, he communicated with the company back and

forth via email regarding the position. It was only when the company asked Mr. Diggin for his license number that he stopped responding. The prosecutor recommended a fine of \$500 as a sanction for the violation of the Cease and Desist Order.

On June 15, 2023, Panel B issued an Order finding that Mr. Diggin violated the September 17, 2021 Cease and Desist Order and, as a sanction, imposed upon Mr. Diggin a fine of \$1,000 to be paid within one year.

Second Violation of Cease and Desist Order (at Issue in this Proceeding)

On December 1, 2023, the Board received a complaint from a member of an online medical roleplaying group stating that Mr. Diggin presented several falsified documents claiming to be a physician assistant. The Board's investigation revealed that in attempting to authenticate his credentials to the online group, Mr. Diggins provided a fake diploma from St. George University School of Medicine with his name and identifying himself as a doctor of medicine.

On July 25, 2024, Panel B issued a Violation of Cease and Desist Order and Notice to Show Cause informing Mr. Diggin of the nature of the violation and that a hearing was scheduled in the matter for August 28, 2024. The Violation included a cover letter which encouraged Mr. Diggin to retain counsel and informed Mr. Diggin that if he or his attorney failed to appear at the Show Cause hearing that the Panel might take further disciplinary action against him in his absence.

On August 23, 2024, the Board received Mr. Diggin's request to reschedule the August 28th hearing date for the purposes of retaining counsel. On August 26, 2024, the Board informed Mr. Diggin that his postponement request was granted and that the new hearing was scheduled for October 23, 2024, at 10:30 am. On October 15, 2024, Mr. Diggin's guardian sent an email to the

Board stating that she was unable to find an attorney, but that she and Mr. Diggin would be at the hearing unassisted by counsel.

On October 23, 2024, Mr. Diggin did not appear at the Show Cause hearing before Panel B. The State appeared and was represented by the administrative prosecutor. The Panel waited until 11:24 am to begin the hearing. At the hearing, the administrative prosecutor presented the State's case and entered into evidence 14 exhibits for the Panel's consideration. Mr. Diggin did not appear at the Show Cause hearing, and, therefore, the violation is unopposed. The administrative prosecutor recommended a fine of \$10,000, in accordance with the Board's regulations for a second violation.

CONCLUSION OF LAW

Panel B concludes that Mr. Diggin violated the September 17, 2021 Cease and Desist Order a second time by representing to the public, by title, description of services, methods, procedures, or otherwise, that he is authorized to practice medicine in Maryland.

SANCTION

Pursuant to COMAR 10.32.02.11E(4)(a), the Board may impose a fine as provided in Regulation .09C on any individual who violates a Cease and Desist Order. The range of fines imposable for a second violation is "not less than \$10,000 and not more than \$40,000[.]" COMAR 10.32.02.09C(3)(a)(ii). The Panel has determined that a \$10,000 fine is appropriate in this case for Mr. Diggin's second violation of the September 17, 2021 Cease and Desist Order.

ORDER

It is, thus, by Board Disciplinary Panel B, hereby

ORDERED that, within **ONE YEAR**, Mr. Diggin shall pay a civil fine of \$10,000.00. The Payment shall be by money order or bank certified check made payable to the Maryland Board of Physicians and mailed to P.O. Box 37217, Baltimore, Maryland 21297; and it is further

ORDERED that this Order is a public document. *See Gen. Prov. § 4-101 et. seq.*

NOTICE OF RIGHT TO PETITION FOR JUDICIAL REVIEW

Pursuant to COMAR 10.32.02.11E(4)(f), Mr. Diggin has the right to seek judicial review of this Violation of Show Cause Order. Any petition for judicial review shall be filed within thirty (30) days from the date of mailing of this Order. The cover letter accompanying this Order indicates the date the decision is mailed. Any petition for judicial review shall be made as provided for in the Administrative Procedure Act, Md. Code Ann., State Gov't § 10-222 and Title 7, Chapter 200 of the Maryland Rules of Procedure.

If Mr. Diggin files a petition for judicial review, the Board is a party and should be served with the court's process at the following address:
