ORDER TERMINATING PROBATIONARY CONDITION

On May 18, 2010, the Maryland State Board of Physicians (“Board”) issued a Final Decision and Order finding that Daniel P. Doyle, RCP was guilty of unprofessional conduct in the practice of respiratory care, in violation of section 14-5A-17(a)(3) of the Health Occupations Article. The Board suspended Mr. Doyle’s respiratory care license and ordered him to complete certain terms and conditions before he could resume the practice of respiratory care.

On May 9, 2012, the Board issued an Order terminating suspension and imposing probation for a minimum period of five (5) years with certain terms and conditions.¹ Condition 1 of the Order Terminating Suspension and Imposing Probation required Mr. Doyle to receive therapy from a Board-approved psychologist, licensed therapist, or psychiatrist for a minimum period of one (1) year. The Board has received documentation that Mr. Doyle has successfully completed probationary Condition 1. Accordingly, it is by Disciplinary Panel B² (“Panel B”) of the Board, hereby

ORDERED that probationary condition 1 of the May 9, 2012 Order Terminating Suspension and Imposing Probation is **SATISFIED**; and it is further

ORDERED that the probation³ imposed by the May 9, 2012 Order Terminating Suspension and Imposing Probation shall continue until Mr. Doyle successfully completes the remaining probationary terms and conditions:

1. Upon being hired, Mr. Doyle must notify the Board, through the Board's Probation Unit, of where he anticipates working. Mr. Doyle's employment setting must be approved by the Board. Mr. Doyle must provide the Board with the information the Board requests about the anticipated employment setting, so that the Board can make an informed decision.
2. Mr. Doyle shall only work daytime hours for a minimum period of one (1) year.
3. Mr. Doyle shall be under the supervision of a Board-approved supervisor for a minimum period of one (1) year. The supervisor will issue quarterly reports to the Board detailing Mr. Doyle's workplace behavior. An unsatisfactory report may be considered a violation of probation.
4. After a period of one (1) year, if the supervisory reports are deemed satisfactory by the Board, Mr. Doyle may petition the Board's Investigative Review Panel for the termination of conditions 2 and 3.
5. Mr. Doyle must comply with the Maryland Respiratory Care Practitioners Act, Md. Code Ann., Health Occ. §§ 14-5A-01 – 14-5A-25, and all laws, regulations, and rules, governing the practice of respiratory care in Maryland; and it is further

ORDERED that after Mr. Doyle has fully and satisfactorily completed the remaining probationary terms and conditions, he may submit a written petition to Panel B requesting termination of probation. Mr. Doyle's probation will be terminated through an order of Panel B

if Mr. Doyle has satisfactorily complied with all the probationary terms and conditions and there are no pending complaints relating to the charges; and it is further

ORDERED that Mr. Doyle is responsible for all costs incurred in fulfilling the terms and conditions of this order; and it is further

ORDERED that if Mr. Doyle violates any condition of probation or this Order, Panel B, after notice and an opportunity to be heard, may impose any additional sanction, authorized under § 14-5A-17 of the Health Occupations Article, including a reprimand, additional conditions of probation, or the suspension or revocation of his license to practice respiratory care; and it is further

ORDERED that this is a public document.
