Dear Ms. Hyler and Mr. Brown:

On March 2, 2020, Disciplinary Panel A of the Maryland State Board of Physicians issued an **ORDER FOR SUMMARY SUSPENSION OF LICENSE TO PRACTICE RADIATION THERAPY** in this case, pursuant to Md. Code Ann., State Gov't, § 10-226(c)(2)(i) (2014 Repl. Vol. & 2019 Supp.). That Order was sent to Ms. Hyler via electronic mail and via UPS Next Day Air to her address on record with the Board, which is the address that she provided at her interview with Board staff.

Pursuant to the Order for Summary Suspension, the hearing was scheduled on March 11, 2020 at 11:15 a.m. By 1:30 p.m., Ms. Hyler had not appeared. At 1:30 p.m., Panel A held a postdeprivation hearing to show cause why that suspension should not be continued on the record. The State was represented by Michael Brown, Assistant Attorney General, Administrative Prosecutor.

After considering the investigative file and the oral presentation by Mr. Brown, Disciplinary Panel A determined that it would continue the summary suspension imposed on March 2, 2020. Disciplinary Panel A thus will not lift the summary suspension order. Disciplinary Panel A finds that the public health, safety or welfare imperatively requires the suspension of Ms. Hyler's license. *See* State Gov't, § 10-226(c)(2)(i). The order of summary suspension is thus reaffirmed and continues. *See* COMAR 10.32.02.08H(1).

NOTICE OF RIGHT TO APPEAL

Under the Board regulations, Ms. Hyler has the right to request a full evidentiary hearing before an Administrative Law Judge at the Office of Administrative Hearings. To receive the evidentiary hearing, Ms. Hyler or her counsel must file the request for the hearing within **TEN (10)** days of the date of this letter. The request for a hearing should be sent to Christine A. Farrelly, Executive Director, at the Board's address. If the hearing is timely requested, the regulations require that an Administrative Law Judge set the hearing to begin within 30 days of the request, *see* COMAR 10.32.02.08I, though that 30-day time period may be waived.

This letter constitutes an order of the Board through Disciplinary Panel A resulting from formal disciplinary action and is therefore a public document.
