**CONSENT ORDER**

In or around October 2024, the Maryland State Board of Physicians (the “Board”), Disciplinary Panel A (“Panel A”) initiated an investigation of **LAKEISHA GILLISON, Radiographer** (the “Respondent”), License Number R0011005, based on allegations that she practiced radiography without a license. At the conclusion of its investigation, Panel A of the Board determined it had grounds to charge the Respondent with violating the Maryland Radiation Therapy, Radiography, Nuclear Medicine Technology, and Radiology Assistance Act (the “Act”), Md. Code Ann., Health Occupations (“Health Occ.”) §§ 14-5B-01 *et seq.* (2021 Repl. Vol. & 2024 Supp.).

The pertinent provision of the Act is as follows:

**Health Occ. § 14-5B-17. Unauthorized practice prohibited.**

- (c) Except as otherwise provided in this subtitle, a person may not practice, attempt to practice, or offer to practice radiography in this State unless licensed to practice radiography by the Board.

Prior to the issuance of disciplinary charges, the Respondent agreed to enter into the following Consent Order, consisting of Findings of Fact, Conclusions of Law, Order, and Consent.

## **FINDINGS OF FACT**

Panel A makes the following Findings of Fact:

1. The Respondent was originally licensed to practice radiography in the State of Maryland on May 27, 2014, under license number R0011005. The Respondent's license is current through April 30, 2025.
2. On or about April 30, 2023, the Respondent's license expired.
3. On or about September 17, 2024, the Respondent submitted an Application for Reinstatement of Radiographer ("Application"). In her Application, the Respondent stated that she worked as a Radiologic Technologist at a healthcare facility located in Baltimore, Maryland and at a healthcare facility located in Annapolis, Maryland.
4. On or about October 17, 2024, the Board reinstated the Respondent's license.
5. The Board initiated an investigation of the Respondent after reviewing the statements she made in her Application. The Board's investigation determined that from on or about May 1, 2023 to on or about September 19, 2024, the Respondent practiced radiography in Maryland without a license.

## **CONCLUSIONS OF LAW**

Based on the foregoing Findings of Fact, Panel A concludes as a matter of law that the Respondent practiced radiography without a license, in violation of Health Occ. § 14-5B-17(c).

## **ORDER**

It is, on the affirmative vote of a majority of the quorum of Panel A, hereby:

**ORDERED** that the Respondent is hereby **REPRIMANDED**; and it is further

**ORDERED** that, within **ONE (1) YEAR** of the effective date of the Consent Order, the Respondent shall pay a civil fine of **ONE THOUSAND DOLLARS (\$1,000)**. The payment shall be by money order or bank certified check made payable to the Maryland Board of Physicians and mailed to P.O. Box 37217, Baltimore, Maryland 21297. The Board will not renew or reinstate the Respondent's license if the Respondent fails to pay the fine; and it is further

**ORDERED** that the effective date of the Consent Order is the date the Consent Order is signed by the Executive Director of the Board or her designee. The Executive Director signs the Consent Order on behalf of the disciplinary panel which has imposed the terms and conditions of this Consent Order; and it is further

**ORDERED** that this Consent Order is a public document. *See* Md. Code Ann., Health Occ. §§ 1-607, 14-411.1(b)(2) and Gen. Prov. § 4-333(b)(6).

I waive those procedural and substantive protections. I acknowledge the legal authority and the jurisdiction of the Board to initiate these proceedings and to issue and enforce this Consent Order.

I voluntarily enter into and agree to comply with the terms and conditions set forth in the Consent Order as a resolution of the pending disciplinary matters. I waive any right to contest the Findings of Fact and Conclusions of Law and Order set out in this Consent Order. I waive all rights to appeal this Consent Order.

I sign this Consent Order, without reservation, and I fully understand and comprehend the language and meaning of its terms.
