## CONSENT ORDER

On or about September 15, 2022, Disciplinary Panel B ("Panel B") of the Maryland State Board of Physicians (the "Board"), opened an investigation of Gary Floyd, Radiographer (the "Respondent"), under the Maryland Radiation Therapy, Radiography, Nuclear Medicine Technology, and Radiology Assistant Act (the "Act"), Md. Code Ann., Health Occ. ("Health Occ.") §§ 14-5B-01 *et seq.* 

Based on its investigation, the Board has grounds to charge the Respondent under the following provision of the Act:

## Health Occ. § 14-5B-17. Unauthorized practice prohibited

\* \* \*

(c) Except as otherwise provided in this subtitle, a person may not practice, attempt to practice, or offer to practice radiography in this State unless licensed to practice radiography by the Board.

Prior to Panel B issuing charges, the Respondent agreed to enter into this public Consent Order with the Panel B's approval, consisting of Findings of Fact, Conclusions of Law, and Order.

# FINDINGS OF FACT

Panel B finds the following:

 The Respondent was originally licensed by the Board to practice Radiography on June 26, 1991.

- 2. The Respondent's license was set to expire on April 30, 2021.
- 3. Because of extensions related to the COVID pandemic, the Respondent's license expired on June 30, 2021.
- 4. The Respondent continued to practice as a radiographer in Maryland from July 1, 2021 through August 2022.
- 5. On August 1, 2022, the Respondent filed an Application for Reinstatement of Radiographer.
- 6. In his application the Respondent admitted to practicing as a radiographer in Maryland from December 2017 to August 2022.
- 7. The Respondent, thus, practiced radiography without a license from approximately July 1, 2021 to August 1, 2022.

#### CONCLUSIONS OF LAW

Based upon the foregoing Findings of Fact, Disciplinary Panel B concludes that the Respondent engaged in the unauthorized practice of radiography in Maryland, in violation of Health Occ. § 14-5B-17(c).

## ORDER

It is, thus, by Disciplinary Panel B, hereby:

ORDERED that, within SIX MONTHS of the effective date of this Consent Order, the Respondent shall pay a civil fine of \$500.00 by bank certified check or money order made payable to the Maryland Board of Physicians, P.O. Box 37217, Baltimore, Maryland 21297. The Board will not renew or reinstate the Respondent's license if the Respondent fails to timely pay the fine to the Board.; and it is further

**ORDERED** that the effective date of the Consent Order is the date the Consent Order is signed by the Executive Director of the Board or her designee. The Executive Director or her designee signs the Consent Order on behalf of the disciplinary panel which has imposed the terms and conditions of this Consent Order; and it is further

**ORDERED** that this Consent Order is a public document. See Health Occ. §§ 1-607, 14-411.1(b)(2) and Gen. Prov. § 4-333(b)(6); and it is further
