<u>ORDER</u>

On April 28, 2023, Disciplinary Panel A ("Panel A") of the Maryland State Board of Physicians (the "Board") notified Adventist Healthcare Shady Grove Medical Center (the "Respondent") of its failure to comply with provisions of the Maryland Medical Practice Act (the "Act"), Md. Code Ann., Health Occ. ("Health Occ.") §§ 14-101 et seq. (2021 Repl. Vol. & 2022 Supp.).

The pertinent provisions of the Act are as follows:

§ 14-5A-22.1. Employment or supervision of individuals practicing respiratory care

- (b) Hospitals, related institutions Except as otherwise provided in this subtitle, a hospital, related institution, alternative health system, or employer may not employ an individual practicing respiratory care without a license.
- (c) Civil penalties A disciplinary panel may impose a civil penalty of up to \$1,000 for violation of this section.

On July 12, 2023, Panel A was convened as a Disciplinary Committee for Case Resolution ("DCCR") in this matter. Based on the negotiations occurring as a result of this

DCCR, the Respondent agreed to enter into this Consent Order, consisting of Findings of Fact, Conclusions of Law, Order, and Consent.

FINDINGS OF FACT

Panel A finds:

- 1. On or about November 9, 2022, the Board received a reinstatement application for a Maryland licensed respiratory care therapist (the "Respiratory Care Therapist").
- 2. In the reinstatement application, the Respiratory Care Therapist documented that her license expired on May 30, 2022, and she was employed by the Respondent and had practiced in Maryland until October 2022.
- 3. Based on the information in the reinstatement application (the "Complaint"), the Board initiated an investigation.
- 4. In furtherance of the investigation, the Board's investigator subpoenaed the Respiratory Care Therapist's relevant personnel records.
- 5. On or about December 22, 2022, the Board notified the Respondent by letter of the Board's investigation and requested a written response.
- 6. On or about January 12, 2023, the Board received a written response from the Respondent. The Respondent stated, among other things, that: (1) on or about November 29, 2021, the Respondent hired the Respiratory Care Therapist who was properly licensed at that time; (2) the Respondent conducted an audit in October 2022 which determined that the Respiratory Care Therapist's license had expired on May 30,

2022; and (3) the Respondent subsequently suspended the Respiratory Care Therapist's employment.

CONCLUSIONS OF LAW

Based on the foregoing findings of fact, Disciplinary Panel A concludes as a matter of law that the Respondent employed an individual to practice respiratory care without a license, in violation of Md. Code Ann., Health Occ. § 14-5A-22.1(b).

<u>ORDER</u>

ORDERED that within **60 DAYS** from the effective date of this Order, the Respondent shall pay a civil fine of **ONE THOUSAND DOLLARS** (\$1,000.00). The Payment shall be by money order or bank certified check made payable to the Maryland Board of Physicians mailed to P.O. Box 37217, Baltimore, Maryland 21297.
