**ORDER**

On June 28, 2021, Disciplinary Panel B (the "Panel") of the Maryland State Board of Physicians (the "Board") and Susan Williams entered into a Consent Order, wherein Panel B concluded, as a matter of law, that Ms. Williams practiced, attempted to practice, or offered to practice naturopathic medicine in the State of Maryland without a license; represented to the public by title, by description of services, methods, or procedures, or otherwise, that she was licensed by the Board to practice naturopathic medicine in Maryland; used the title "doctor of naturopathic medicine," "doctor of naturopathy," "naturopathic doctor," or "naturopath" without being licensed to practice naturopathic medicine in Maryland; and used the initials "N.D.," "ND," "NMD," or "N.M.D.," after her name without being licensed to practice naturopathic medicine in Maryland. Ms. Williams was ordered to cease and desist from practicing, attempting to practice, or offering to practice naturopathic medicine in Maryland; from representing to the public by title, by description of services, methods and procedures, and otherwise, that she is licensed to by the Board to practice naturopathic medicine in Maryland; from using the title "doctor of naturopathic medicine," "doctor of naturopathy," "naturopathic doctor," "naturopath," or "naturopathic physician" to represent, indicate, or suggest that she is licensed by the Board to practice naturopathic medicine in Maryland; from using the initials "N.D.," "ND," "NMD," or "N.M.D.," after her name to represent, indicate, or suggest that she is licensed by the Board to

practice naturopathic medicine in Maryland, and ordered to pay a fine of \$2,500.00 within two (2) years. Ms. Williams has paid the \$2,500.00 fine. It is thus hereby

**ORDERED** that the fine imposed by the June 28, 2021 Consent Order has been **SATISFIED**; and it is further

**ORDERED** that Ms. Williams shall continue to **CEASE AND DESIST** from practicing, attempting to practice, or offering to practice naturopathic medicine in Maryland; from representing to the public by title, by description of services, methods and procedures, and otherwise, that she is licensed to by the Board to practice naturopathic medicine in Maryland; from using the title “doctor of naturopathic medicine,” “doctor of naturopathy,” “naturopathic doctor,” “naturopath,” or “naturopathic physician” to represent, indicate, or suggest that she is licensed by the Board to practice naturopathic medicine in Maryland; and from using the initials “N.D.,” “ND,” “NMD,” or “N.M.D.” after her name to represent, indicate, or suggest that she is licensed by the Board to practice naturopathic medicine in Maryland; and it is further

**ORDERED** that this is a public document.
