CONSENT ORDER

PROCEDURAL BACKGROUND

On December 21, 2016, Disciplinary Panel B ("Panel B") of the Maryland State Board of Physicians (the "Board") voted to charge **YVES-JACQUES PIQUION, M.D.** (the "Respondent"), License Number D29696, with violating the Maryland Medical Practice Act (the "Act"), Md. Code Ann., Health Occ. ("Health Occ.") §§ 14-101 *et seq.* (2014 Repl. Vol. & 2016 Supp.).

Specifically, Panel B voted to charge the Respondent with violating the following provision of the Act under Health Occ. § 14-404:

- (a) *In general.* -- Subject to the hearing provisions of § 14-405 of this subtitle, a disciplinary panel, on the affirmative vote of a majority of the quorum of the disciplinary panel, may reprimand any licensee, place any licensee on probation, or suspended or revoke a license if the licensee:
 - (28) Fails to comply with the provisions of § 12-102 of this article[.]

Md. Health Occ. § 12-102 provides:

- (c) *Preparing of prescriptions by licensed dentist, veterinarian, physician, etc.; exception:*
 - ...
 - (2) This title does not prohibit:
 - ...

- (ii) A licensed dentist, physician, or podiatrist from personally preparing and dispensing the dentist's, physician's, or podiatrist's prescriptions when:
 - 1. The dentist, physician, or podiatrist:
 - A. Has applied to the board of licensure in this State which licensed the dentist, physician, or podiatrist;
 - ...
 - C. Has received a written permit from that board to dispense prescription drugs or devices except that a written permit is not required in order to dispense starter dosages or samples with charge[.]

Prior to the issuance of charges, the Respondent agreed to enter into this public Consent Order, consisting of Procedural Background, Findings of Fact, Conclusions of Law, Order, Consent and Notary.

FINDINGS OF FACT

Panel B of the Board makes the following Findings of Fact:

1. At all times relevant hereto, the Respondent was and is licensed to practice medicine in the State of Maryland. The Respondent was initially licensed to practice medicine in Maryland on or about August 5, 1983, under License Number D29696. The Respondent's license is active and current through September 30, 2019.
2. On or about December 9, 2010, the Board issued the Respondent a dispensing permit under permit # 2418. On or about December 8, 2015, the Respondent's dispensing permit expired. The Respondent did not submit a renewal application for his dispensing permit at that time.
3. On or about August 17, 2016, the Respondent submitted an application to the Board to renew his dispensing permit, which the Board issued.

4. The Board initiated an investigation of the Respondent after reviewing his August 17, 2016 dispensing permit renewal application, in which it noted that his dispensing permit had expired in 2015. In a letter to the Respondent dated October 7, 2016, Board staff requested that he explain why he filed a late renewal application.

5. In a letter to the Board dated October 14, 2016, the Respondent acknowledged that he failed to renew his dispensing permit.

6. The Board's investigation determined that the Respondent dispensed prescription medications after his dispensing permit expired on December 10, 2015, and that he continued to do so until through May of 2016, in violation of Health Occ. §§ 14-404(a)(28).

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, Panel B concludes as a matter of law that the Respondent violated the following provision of the Act: Health Occ. § 14-404(a)(28), Fails to comply with the provisions of § 12-102 of this article.

ORDER

It is, on the affirmative vote of a majority of the quorum of Panel A, hereby:

ORDERED that the Respondent is **REPRIMANDED**; and it is further


ORDERED that within **SIX (6) MONTHS**, the Respondent shall pay a civil fine in the amount of **ONE THOUSAND AND FIFTY DOLLARS (\$1,050.00)**, by money order or bank certified check, made payable to the Maryland Board of Physicians, P.O. Box 37217, Baltimore, Maryland 21297; and it is further

ORDERED that the Consent Order goes into effect upon the signature of the Board's Executive Director, who signs on behalf of Panel B; and it is further

ORDERED that if the Board or Panel B determines, after notice and an opportunity for a hearing before an Administrative Law Judge of the Office of Administrative Hearings if there is a genuine dispute as to a material fact or a show cause hearing before the Board or Panel B if there is no genuine dispute as to a material fact, that the Respondent has failed to comply with any term or condition of this Consent Order, the Board or Panel B may reprimand the Respondent, place the Respondent on probation with appropriate terms and conditions, or suspend or revoke the Respondent's license to practice medicine in Maryland. The Board or Panel B may, in addition to one or more of the sanctions set forth above, impose a civil monetary fine upon the Respondent; and it is further

ORDERED that this Consent Order is a **PUBLIC DOCUMENT** pursuant to Md. Code Ann., Gen. Provisions §§ 4-101 *et seq.* (2014).

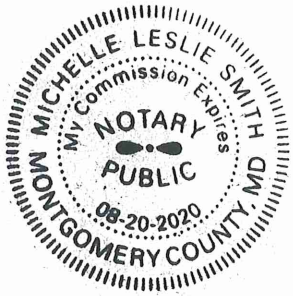
