CONSENT ORDER

The Maryland State Board of Physicians (the "Board") and the Respondent Bryan Costello, A.T., agree to enter into this Consent Order in order to resolve Mr. Costello's unauthorized practice of athletic training.

FINDINGS OF FACT

On or about October 14, 2015, the Board received an Athletic Trainer Application for Licensure wherein Mr. Costello indicated that he was employed as an athletic trainer in Maryland. Mr. Costello was licensed by the Board on November 3, 2015. An Evaluation and Treatment Protocol between Mr. Costello and his supervising physician was approved by the Board on December 11, 2015. Mr. Costello continued to practice athletic training although he did not have a license or an approved evaluation and treatment protocol.

CONCLUSIONS OF LAW

Based upon the findings of fact, the Board concludes that Mr. Costello engaged in the unauthorized practice of athletic training in Maryland, in violation of § 14-5D-17 of the Health Occupations Article, Annotated Code of Maryland.

ORDER

Based upon the findings of fact and conclusions of law, it is, by the Board, hereby

ORDERED that, within 90 days, Mr. Costello shall pay a civil fine of \$250.00 by bank certified check or money order made payable to the Maryland Board of Physicians, P.O. Box 37217, Baltimore, Maryland 21297; and it is further

ORDERED that if Mr. Costello fails to comply with any term or condition of this Consent Order, the Board, after notice and an opportunity to be heard, may impose a further sanction upon Mr. Costello, including an additional fine or the denial of his application for the reinstatement or renewal of her license to practice athletic training in Maryland; and it is further

ORDERED that this is a public document.
