CONSENT ORDER

Disciplinary Panel A ("Panel A") of the Maryland State Board of Physicians (the "Board") and the Respondent, Mikaela Flanagan, A.T., agree to enter into this Consent Order, before charges have been issued, in order to resolve Ms. Flanagan's unauthorized practice of athletic training in Maryland.

The statutory provisions pertinent to this matter are:

Health Occ. § 14-5D-17.

Unless authorized to practice athletic training under this subtitle [Health Occ. §§ 14-5D-01 et seq.], a person may not:

(1) Practice athletic training in this State.

Health Occ. § 14-5D-07(a).

..., an individual shall be licensed by the Board before the individual may practice athletic training in the State.

Health Occ. § 14-5D-11(b).

Before an athletic trainer may practice athletic training, the athletic trainer shall:

(3) ..., submit an original, signed copy of the evaluation and treatment protocol for Board approval.

Health Occ. § 14-5D-18(b).

A person who violates § 14-5D-17 of this subtitle is subject to a civil fine of not more than \$5,000 to be levied by a disciplinary panel.

FINDINGS OF FACT

Panel A makes the following findings of fact:

On or about August 27, 2022, Ms. Flanagan filed an Athletic Trainer Application for Licensure with the Board showing that she began working as an athletic trainer in Maryland in August 2022. Ms. Flanagan, however, was not licensed by the Board to practice as an athletic trainer until December 9, 2022. And an Evaluation and Treatment Protocol between Ms. Flanagan and her supervising physician was not approved by the Board until December 13, 2022. Ms. Flanagan thus practiced athletic training without a license and without an approved evaluation and treatment protocol.

CONCLUSIONS OF LAW

Based upon the findings of fact, Panel A concludes that Ms. Flanagan engaged in the unauthorized practice of athletic training in Maryland, in violation of Health Occ. § 14-5D-17(1); practiced athletic training in Maryland without a license from the Board, in violation of Health Occ. § 14-5D-07; and practiced as an athletic trainer in Maryland without having submitted an evaluation and treatment protocol to the Board for approval, in violation of § 14-5D-11(b)(3) of the Health Occupations Article. Ms. Flanagan is subject to a civil fine by a disciplinary panel for her violation of Health Occ. § 14-5D-17, under Health Occ. § 14-5D-18(b).

ORDER

It is, thus, by Panel A, hereby

ORDERED that, within 90 days, Ms. Flanagan shall pay a civil fine of \$250.00 by bank certified check or money order made payable to the Maryland Board of Physicians, P.O. Box 37217, Baltimore, Maryland 21297; and it is further

ORDERED that this Consent Order goes into effect upon the signature of the Board's executive director or her designee, who signs this document on behalf of the Board disciplinary panel that entered into this Consent Order; and it is further

ORDERED that this is a public document.
