# **CONSENT ORDER**

#### BACKGROUND

Based upon information received by the Maryland Board of Physicians (the "Board"), pursuant to its authority under Md. Health Occ. Ann. ("H.O.") §14-401 et seq., the Board conducted an audit of the continuing medical education credits filed with the reinstatement application of Mehmooda B. Naeem, M.D. (the "Respondent"), License Number D64578. The audit findings provided sufficient evidence to conclude that the Respondent violated the Maryland Medical Practice Act (the "Act"), Md. Health Occ. Code Ann. §14-316 and Code of Maryland Regulations ("COMAR") by failing to complete fifty (50) continuing medical education credits for reinstatement of her license.

H.O. §14-317 provides:

The Board shall reinstate the license of a physician who has failed to renew the license for any reason if the physician:

(1) Meets the renewal requirements of §14-316 of this subtitle;

The pertinent provision of H.O. §14-316 provides:

- (c) Applications for renewal.-- Before the license expires, the licensee periodically may renew it for an additional term, if the licensee:
  - (3) Submits to the Board:

\* \* \*

(ii) Satisfactory evidence of compliance with any continuing education requirements set under this section for license renewal.

The pertinent provisions of COMAR under 10.32.01 provide:

- .11 Reinstatement of Expired or Inactive Licenses.
  - C. A physician applying for reinstatement shall submit documentation of completing the required number of CME hours for reinstatement as defined in Regulation .10 of this chapter.
- .10 Continuing Medical Education.
  - B. Requirements.
    - (1) A physician applying for renewal or reinstatement shall earn at least 50 credit hours of Category I CME during the 2-year period immediately preceding the licensee's submission of the renewal or reinstatement application.
  - C. On the application form for renewal or reinstatement, a physician shall attest to the fact that the physician has completed the continuing medical education requirement.

The Board has agreed to accept the Respondent's voluntary offer to enter into this Consent Order and to submit to the terms and conditions as set out by this Consent Order.

#### FINDINGS OF FACT

- 1. The Respondent was initially licensed to practice medicine in Maryland on May 16, 2006. The Respondent's license expired September 30, 2015.
- 2. On October 14, 2015, the Respondent signed the affirmation in her Application for Reinstatement of Medical Licensure that she had obtained the required 50 Category 1 CME credit hours.
- 3. As part of the reinstatement process, the Respondent is required to submit to the Board documentation of at least 50 credit hours of Category 1 continuing medication education credits within the two years immediately preceding her application for reinstatement.

- 4. Based upon the information received from the Respondent, she had obtained only 33 hours of the required 50 credit hours of Category I CME, not 50 hours as affirmed by the Respondent.
- 5. The Respondent's failure to provide documentation of 50 credit hours of Category I CME and signing the certification regarding CME requirements on the application for reinstatement constitute a failure to comply with the statute and regulations.

### **CONCLUSIONS OF LAW**

Based on the foregoing Findings of Fact, the Board concludes as a matter of law that the Respondent violated §14-316(c) of the Health Occupations Article and COMAR 10.32.01.10B(1) by failing to obtain the requisite continuing medical education credits.

### **ORDER**

It is hereby:

ORDERED that the Respondent shall pay an administrative fine of One Thousand Seven Hundred Dollars (\$1700) (One Hundred Dollars per missing CME credit hour pursuant to §14-316(d)(5) of the Health Occupations Article) to the Board within thirty (30) days after the effective date of this Order. The check should be made payable to the "Maryland Board of Physicians" and mailed to P. O. Box 37217, Baltimore, Maryland 21297-3217; and be it further

**ORDERED** that the Respondent shall be subject to the following terms and conditions:

- 1. For the two year period immediately preceding the 2017 renewal (2015-2017 renewal), the Respondent shall obtain the required 50 credit hours of Category I CME mandatory for the 2017 renewal and the outstanding 17 hours of Category I CME credits that were not obtained during the two year period immediately preceding the reinstatement application, a total of 67 Category I CME credit hours;
- 2. The Respondent shall send verification of all continuing medical education credits prior to sending in the 2017 renewal to the Board. Board staff will verify the 67 hours of

Category I CME credits that are sent to the Board. All 67 hours of the Category I CME credits must be ACCME-approved;

- 3. The Respondent's license shall not be renewed in 2017 unless the requirements of paragraphs 1 and 2 are met;
- 4 If the Board determines that the Respondent has violated any conditions of the Consent Order, the Board may impose any additional disciplinary sanctions it deems appropriate; and be it further

**ORDERED** that this is a public document of the Maryland Board of Physicians pursuant to Md. Code Ann., Gen. Prov. §§4-101 – 4-601 (2014).
