ORDER

On January 10, 2024, Disciplinary Panel B (the “Panel”) of the Maryland State Board of Physicians (the “Board”) issued a Cease and Desist Order, wherein the Panel concluded, as a matter of law, that Kai Parker practiced, attempted to practice, or offered to practice naturopathic medicine in Maryland without a license, in violation of Health Occ. § 14-5F-29(a); represented to the public by title, by description of services, methods, or procedures, or otherwise, that she was licensed by the Board to practice naturopathic medicine, in violation of Health Occ. § 14-5F-30(a)(1); used the title “naturopathic doctor” in Maryland without being licensed by the Board, in violation of Health Occ. § 14-5F-30(a)(2); used the initials “ND” after her name in Maryland without being licensed by the Board, in violation of Health Occ. § 14-5F-30(a)(3); used the title “physician” while she was licensed to practice to practice naturopathic medicine in Maryland, in violation of Health Occ. § 14-5F-30(b); represented to the public, by description of services, methods, or procedures, or otherwise, that she was authorized to practice medicine in Maryland, in violation of Health Occ. § 14-602(a); and used the terms “Dr.”, “doctor”, and “physician” with the intent to represent that she practiced medicine, in violation of Health Occ. § 14-602(b).

On June 3, 2024, the Panel and Ms. Parker entered into a Consent Order,¹ wherein the Panel concluded, as a matter of law, that Ms. Parker violated Health Occ. § 14-5F-30(a)(1), (2), (3), and (30)(b)

of the Maryland Naturopathic Medicine Act and Health Occ. § 14-602(a) and (b) of the Maryland Medical Practice Act. The Consent Order ordered Ms. Parker to pay a civil fine of five thousand dollars (\$5,000.00) within two (2) years and ordered that the January 10, 2024 Cease and Desist Order remain in full force and effect until Ms. Parker's Maryland license as a Naturopathic Doctor is reinstated.

Ms. Parker has paid the \$5,000.00 civil fine.

It is thus, by the Panel, hereby

ORDERED that the fine imposed by the June 3, 2024 Consent Order has been **SATISFIED**, and it is further

ORDERED that the January 10, 2024 **CEASE AND DESIST ORDER** remains in effect and it further

ORDERED that this is a public document.
