### **CALL TO ORDER**

Jeffrey Sagel, D.O. called the meeting to order at 4:06 pm.

#### APPROVAL OF MINUTES

On a motion made by Ms. Lewis and seconded by Ms. Tannehill, the Committee approved the July 7, 2016 Open Meeting Minutes.

#### LEGISLATIVE REPORT

Mr. Woodard informed the Committee that the 2017 Legislative Session will conclude at midnight, Monday, April 10, 2017 and that there were no bills impacting perfusionists during this session. He also informed the Committee that regulations implementing a change in the Perfusionist statute resulting from 2014 legislation were finalized and adopted in the summer of 2016. The adopted regulations amended the civil fine authority of the Board, altered the circumstances for reinstatement, provided for a temporary license prior to passing the national certifying examination, and altered the membership on the Perfusion Advisory Committee.

## **United Therapeutics – Ex-Vivo Perfusionist Position Advertisement**

Ms. Farrelly informed the Committee that the Board had previously approved the facility to hire individuals for the clinical trial until the clinical trials are complete. She also informed the Committee that the clinical trial has an estimated end date of 2018.

## **Perfusion License Renewal Fee Estimate**

Mr. Wierscke asked if there was an update on the renewal fee estimate. Ms. Smith informed the Committee that the Board approved the renewal fee of \$221 in 2015, and in addition to the \$221 fee, the Maryland Health Care Commission (MHCC) accessed a fee of \$35, totaling a renewal fee \$256 in 2016. Ms. Smith also stated that it's possible that the MHCC fee will decrease for the next renewal year. However, the Board has not been notified of what that fee will be at this time.

Ms. Wright asked that all Committee members complete the Financial Disclosure statements by the April 30, 2017, deadline. She also informed them that committee members whose terms are ending in June 2017, must also complete the Termination Disclosures.
