# POLICY/LEGISLATION Regulations

#### Petition for Declaratory Ruling - FYI

As follow up to the Board's vote to deny a Petition for Declaratory Ruling in December, Ms. Hawk presented a response letter from the Petitioners as an FYI.

## Petition for Declaratory Ruling for Discussion and Approval

A second Petition was presented on behalf of multiple cardiologists who are interested in providing cardiac Positron Emission Tomography (PET) imaging in their offices. PET imaging is not specifically enumerated in the self-referral law and the Board was requested to interpret the existing exemptions in HO § 1-302 (d)(4) to include PET imaging, and to allow cardiologists to utilize PET/CT equipment in the office.

On a motion made by <u>Mr. Dills</u>, and seconded by <u>Ms. Schaerr</u>, the Board voted to unanimously <u>DENY</u> the request for a Declaratory Ruling as not within the authority of the Board to amend the MPRL to permit application or expansion of the exemption in these circumstances.

# Updating COMAR 10.32.10 for Discussion and Approval

Ms. Van Horn presented a draft of revisions for COMAR 10.32.10 as recommended by the Radiation Therapy, Radiography, Nuclear Medicine Technology, and Radiology Assistance Advisory Committee. The draft includes numerous changes, including but not limited to updates related to legislation, the addition of two definitions, and revisions for clarity or for consistency. The next step would be to post the draft regulations on the Board's Website to invite informal comments.

On a motion made by <u>Mr. Dills</u>, and seconded by <u>Dr. Plavner</u>, the Board voted to unanimously <u>APPROVE</u> to post the draft regulations on the website for informal comments.

# **Update – Physician Assistant Regulations – COMAR 10.32.03 for Discussion and Approval**

Ms. Hawk presented the draft physician assistant regulations for informal posting on the Board website.

On a motion made by <u>Mr. Dills</u>, and seconded by <u>Ms. Schaerr</u>, the Board voted to unanimously <u>APPROVE</u> to post the updated regulations on the website for informal comments.

#### **OCSA Fund Transfer - Dispensing for Discussion**

Ms. Hawk also presented a follow up discussion related to the transfer of dispensing permit funds to OCSA and the concept of proposing legislation to address the ongoing issues with physician dispensing permit inspections.

On a motion made by <u>Dr. Plavner</u>, and seconded by <u>Mr. Dills</u>, the Board voted to unanimously <u>APPROVE</u> to pursue a legislative proposal to transfer physician dispensing permit inspections from OCSA to the Board.

#### **Taskforce/Workgroup**

#### **Naturopathic Doctors Formulary Council Recruitment**

Ms. Van Horn presented recruitment matters for the NDFC. Four members are seeking reappointment. The NDFC chair is not seeking reappointment but communicated to the Board about staying on the NDFC until a replacement is determined. At this time, applicants are needed for two seats on the NDFC. For the pharmacist seat, the Board received a resume; however, the individual did not meet the requirement in statute.

Statute states that the NDFC is to include one "pharmacist who has a background in pharmocognosy" (and who practices in the State). There was discussion about reposting a recruitment notice on the Board's Website and the possibility of waiving the pharmocognosy requirement for a pharmacist depending on the results of the next recruitment effort.

On a motion made by <u>Dr. Freas</u>, and seconded by <u>Ms. Schaerr</u>, the Board voted to unanimously <u>APPROVE</u> to repost the regulations on the website for comments and consider waiving requirements until the next recruitment.

#### **Transplant Surgent**

Dr. Freas stated that he had a licensure issue to discuss with the Board. Dr. Freas received a request for a second renewal of a Limited License for Postgraduate Teaching (LLPT) from Dr. Georgios Vrakas, Associate Professor, Department of Surgery, Director, Kidney Transplant Program, University of Maryland Medical Center. The Board issued the LLPT on August 8, 2019, and renewed it on September 17, 2020. It will expire on September 30, 2021.

On a motion made by <u>Dr. Freas</u>, and seconded by <u>Dr. Boursiquot</u>, the Board voted to grant a one-time extension to Dr. Vrakast due to the Covid-19 pandemic and State of Emergency.

Staff will draft a letter for Dr. Freas's signature granting the extension. Therefore, Dr. Vrakas's current LLPT will expire on March 31, 2022. No further extensions will be granted.
