POLICY/LEGISLATION

Policy

Office for the Attorney General – Concerns with Health Occupations Article §14-410 as it relates to SB 161 and HB 241 (State Board of Physicians – Dispensing Permits)

Senate Bill 161 and House Bill 241 (State Board of Physicians - Dispensing Permits) sought to consolidate disciplinary authority, issuing dispensing permits, and inspection authority within the Board, which we support. The Office of the Attorney General, specifically the Health Education and Advocacy Unit and the Medicaid Fraud Control Unit, expressed concerns over such

consolidation and identified §14-410 as a concern. The §14-410 states that except in specific circumstances or in the case that express stipulation and consent of all parties is given, all proceedings from the Board, a disciplinary panel, or any of its other investigatory bodies, including files, records, or any orders passed by the Board, are not discoverable and are not admissible as evidence in criminal and civil court. The Board resists making any changes to §14-410, and did agree to hold a stakeholder meeting to discuss further. The stakeholder meeting is in the process of being scheduled.

Legislation

H.R. 7939 – Veterans Auto and Education Improvement Act of 2022

Mr. Tran provided an FYI for the Board regarding federal legislation called the Veterans Auto and Education Improvement Act of 2022, which would require the Maryland Board of Physicians to provide licensure exemptions to qualified Military Members and their Spouse.

LEGISLATIVE UPDATE

Mr. Dudzic provided a review of the 2023 legislative session of the Maryland General Assembly. Mr. Dudzic informed the Board that its physician emeritus proposal had passed and been signed into law, and that Board staff had begun developing applications and procedures to implement it in advance of its effective date of October 1, 2023. Mr. Dudzic also provided updates regarding the Board's other two legislative proposals, inspection of dispensing permits and general provisions, both of which passed in the House but ran out of time in the Senate.

EXECUTIVE DIRECTOR'S REPORT

Ms. Farrelly, updated the Board regarding the following:

- 1. FSMB will cover the Uniform Application's cost starting May 1, 2023 for the pilot program. Ms. Farrelly explained that anyone coming to the Board's website who wants to start an initial medical license will be directed to the Uniform Application page through the Federation's Application website. The licensure application costs between \$60.00 to \$65.00 and can be used in almost every state in the US. The pilot project with FSMB is importing application data, which will speed up the licensure process.
- 2. MBP staff watched the confirmation hearings and discovered the board would obtain some new members. The Governor's Appointment Office has not communicated with our MDH Health Occupations Boards and Commissions Office, so we are still awaiting an official notice. Ms. Farrelly mentioned that Mr. Sauvageot's last board meeting was today and thanked him for his service. If a board member's term expires, the Governor's Office replaces them with a new appointee. She informed the board members to continue their terms until they heard differently. Dr. Plavner and Ms. Senft received letters from the Governor's Office stating they would be replaced effective July 1, 2023. Ms. Farrelly will inform the board members of any updates as she receives them. To maintain the proper balance of our Board, Ms. Farrelly will ask some of the Panel A members to switch to Panel B. Dr. Freas also thanked the Board members for their service.
