NEW BUSINESS

Nomination and Election of a new Chair

On a motion made by Dr. Adil Degani and seconded by Ms. Banks, the Committee unanimously voted to table the nomination and election until the October 2017 meeting.

Introduction of Guest Committee Members

The Respiratory Care Professional Standards Committee members and Polysomnographic Professional Standards Committee members in attendance introduced themselves to each other.

Discussion: Development of Position Statement for the setting up of CPAP/BIPAP Machines

Dr. Brown explained the current state of patient care for CPAP/BIPAP setup and whether statements from the Board reflect current practice. He stated that in the past the Board's website identified this task solely under the scope of practice of respiratory care practitioners. There was a consensus from all of the Committee members present that the setup of a CPAP/BIPAP device also falls under the scope of practice of other healthcare practitioners such as polysomnographic technologists.

The both Committees determined that the devices are consumer grade Durable Medical Equipment (DME's) and consumers can also setup the equipment on their own; however, they may require assistance. The topic of DME companies using trained staff or technicians to complete the setup of CPAP/BIPAP machines was discussed at length with consensus being that employing adequately trained staff/technicians is an acceptable way to provide services to consumers.

In conclusion, the Committees agreed that setup of CPAP/BIPAP equipment goes beyond the scope of practice of respiratory care practitioners and that a position statement should be developed to provide basic guidelines on this issue. Dr. Brown agreed to work on a draft of this statement.
