POLICY/LEGISLATION

Preferred Consent Order Provisions – For Discussion and Approval

Mr. Spivey, Mr. Finkler, and Ms. Rubin presented a proposal with standardized language for the Board to review and approve for consent orders. Dr. Rosenstein suggested modifying the language regarding revocations.

*On a motion made by Mr. Dills, and seconded by Dr. Stephenson Thomas, the Board voted to unanimously **APPROVE** the modified Preferred Consent Order Provisions.*

Draft Sexual Misconduct Regulations – Amending COMAR 10.32.17 Sexual Misconduct

Ms. Van Horn and Ms. Darin presented a draft of the amended sexual misconduct regulations. Board staff recommended posting the proposed draft on the Board’s website for informal comments and to revisit at October’s full Board meeting.

*On a motion made by Dr. Freas, and seconded by Dr. Bhandari the Board voted to unanimously **APPROVE** posting the draft for Sexual Misconduct Regulations on the Board’s website for informal comments and to revisit at its October’s full Board meeting.*

Telehealth Regulations – For Discussion and Approval

Mark Woodard presented the Telehealth regulations for discussion and approval. He mentioned that Board counsel prepared a revised draft that addressed the Office of the Secretary’s concerns.

Board staff recommended approving the revised draft regulations and posting on the Board's website.

*On a motion made by Dr. Rosenstein, and seconded by Dr. Stephenson Thomas, the Board voted to unanimously **APPROVE** the revised Telehealth regulations for posting on the Board's website for informal comments. Dr. Rosenstein abstained.*
