**LEGISLATION, REGULATIONS, AND POLICY UPDATES**

**Review of COMAR 10.32.10**

In the absence of Sandi Van Horn, Health Policy Analyst, Ms. Rubin presented a draft of proposed revisions of COMAR 10.32.10 Licensure of Radiographers, Radiation Therapists, Nuclear Medicine Technologists and Radiologist Assistants for their consideration. Currently, the draft as presented does not incorporate any proposed changes noted in the 2020 Sunset Bill.

The Committee agreed with the proposed draft language. They discussed revising specific areas of the regulations to make them consistent with other allied health regulations, reviewing some of the outdated educational requirements, and changing references to “the referring physician” to “the ordering physician”.
