#### Regulations

Proposed Regulation – Emeritus License Status – Public Comment Update Summary:

Ms. Delgreco presented to the Board the update of the Amendments to COMAR 10.32.01.05, 10.32.01.11, and 10.32.01.12 that were posted on the Board's website for two weeks to solicit public comments; no public comment was received. The Board voted to approve the amendments and approve to continue with the promulgation process.

On a motion made by <u>Dr. Wiesenberger</u>, and seconded by <u>Dr. Ganti</u>, the Board voted to unanimously <u>APPROVE</u> the amendments and to continue with the promulgation process.

Draft of Proposed Changes to COMAR 10.32.08 (Athletic Trainers)

On July 26, 2023, the Board voted to approve posting proposed amendments to COMAR 10.32.08 to the Board's website. The proposed amendments will allow Licensed Athletic Trainers who meet requirements to practice dry needling as a specialized task, as established in statute. Additionally, amendments were made to the sanctioning guidelines.

On a motion made by <u>Ms. Schaerr</u>, and seconded by <u>Dr. Scholz</u>, the Board voted to unanimously <u>APPROVE</u> posting these proposed regulations to the Board's website for public review and comments.

#### **Legislation Update**

Mr. Dudzic provided the Board with an update regarding its legislative proposals. Mr. Dudzic explained that all the Board's full proposals had been submitted to the Office of Government
