NEW BUSINESS

FYI - Changes to the ACR (American College of Radiology) Statement for Supervision of Contrast Media Exams - Aaron T. Scott, MIS, CMNT, NMAA, FSNMMI-TS

Mr. Scott discussed the American College of Radiology's (ACR) updates to their Statement for Supervision of Contrast Media Exams, including Direct Supervision for Contrast Studies, Interpreting/Supervising Physician: MRI/Breast, and Interpreting Physician: CT with the Committee, and requested feedback on potentially changing the Board's regulations to reflect the ACR's updates. The Committee asked Mr. Scott to review the Board's current regulations and prepare a side-by-side comparison of the Board's regulations and the ACR's changes for discussion of possible updates of the regulations at its next meeting.

Mr. Scott will prepare a side-by-side comparison of the Board's regulations and the ACR and bring it back to the Committee for discussion.

Inquiry

The Board received the following question from a Radiographer regarding Scope of Practice: "Can I, as an RT(R) CVT, remove catheters, suture, or deploy femoral closure devices with or w/o a Physician being present in the room with you?"

The Committee stated that, per COMAR 10.32.10.09(C)(3), radiographers can remove catheters and sutures, provided the facility has clear protocols and the licensee has demonstrated competency in performing these procedures. Regarding the use of femoral closure devices with or without a physician present in the room, the Committee said that, although the regulations do not specify the use of femoral closure devices, a physician must be present in the room when a radiographer performs the procedure, but they would need more information.
