On a motion made by <u>Ms. Turnipseed</u>, and seconded by <u>Dr. Scholz</u>, the Board voted to unanimously <u>APPROVE</u> the aforementioned Athletic Trainers Evaluation and Treatment Protocols.

#### **PA Advanced Duty – For Discussion**

The PA Advisory Committee received a question regarding whether Physician Assistants could perform vaginal deliveries as an advanced duty. The PA Advisory Committee recommended that it could be an advanced duty for uncomplicated vaginal deliveries with a supervising physician on site and subject to special education, experience, and training. The Board discussed what education, experience, and training might be necessary. Still, it tabled a vote on the recommendation until the Board received further information about the specific facts concerning the details of the requested advanced duty.

On a motion made by <u>Dr. Stitt</u>, and seconded by <u>Dr. Scholz</u>, the Board voted to unanimously <u>TABLE</u> the PA Advanced Duty for Discussion until further information is available.

On a motion made by <u>Dr. Scholz</u>, and seconded by <u>Mr. Sauvageot</u>, the Board voted to unanimously <u>APPROVE</u> the full Board and Panel minutes.

#### LEGISLATIVE UPDATE

Mr. Dudzic informed the Board that the cross-over deadline of the legislative session had past, and updated the Board on the status of the Board's three legislative proposals and other pending legislation with potential Board impact. Mr. Dudzic also reviewed the timeline for the final weeks of the legislative session.

#### **EXECUTIVE DIRECTOR'S REPORT**

- 1. Licensure by Reciprocity for physicians went live on March 10, 2023. The Reciprocity Agreement was signed on March 1, 2023, by VA, DC, and MD agreeing that our physician licensure qualifications are substantially similar. Once licensed in one jurisdiction, you can request a license in the two others through reciprocity. This eliminates the need for primary source credentials and is an expedited process.
- 2. The PDMP Advisory Committee needs a physician representative. Dr. Olszyk has served for six years, so please contact him for additional details.
- 3. The PA Compact was signed into law in Utah.
- 4. Dr. Ritter, Mr. Finkler, Mr. Duzdic, and I are participating in a Telehealth Workgroup at MHCC. It's been very positive so far, and we are looking at ways to improve licensure portability. One possible approach is to enact additional exceptions to licensure.

- 5. As the Board is aware, we have been working with FSMB to receive data in lieu of paper credentials. As part of that pilot project, FSMB will be providing the Uniform Application free of charge to new physician applicants for at least three months beginning on May 1st. The goal of this project, along with reciprocity and endorsement, is to reduce the administrative burden for applicants.
- 6. IMLCC Follow-up. We received notice that the IMLCC will be re-publishing the RFP for its multi-million dollar "enhanced physician portal" as a result of the concerns raised about the RFP process by the Board. However, the Executive Director and Executive Committee have rushed through a new "procurement procedure" without input from the Rules Committee or any Commissioners. The new procedure will degrade the RFP process even further than it already is. The EC approved that only it will do everything related to the RFP with even less transparency, no oversight, no Technology Committee involvement, and no checks or balances.
