CALL TO ORDER

In the absence of Dr. Passero, Ms. Wright called the meeting to order at 2:03 p.m.

APPROVAL OF MINUTES

On a motion made by Dr. Farmer and seconded by Dr. Paddock, the NMAC unanimously voted to table the approval of the Open and Closed Meeting Minutes for September 20, 2024, until the next meeting because three of the four members present were not present at the September 20, 2024 meeting. Therefore, they were unable to vote.

LEGISLATIVE UPDATE

Ms. DelGreco presented proposed amendments to COMAR 10.32.21 *Licensure, Regulation, and Discipline of Naturopathic Doctors*. The amendments clarified that a collaboration and consultation agreement must be maintained to practice naturopathic medicine, inserted standard language for reinstatement of a license after lapse or expiration, and inserted standard language for reinstatement of a license after revocation or surrender. On a motion by Dr. Paddock and seconded by Dr. Farmer, the Committee voted to recommend the amendments to the Board.

Ms. DelGreco provided an update on SB 423/HB 776 - Maryland Medical Practice Act and Maryland Physician Assistant Act - Revisions ("General Revisions") and explained the changes to the naturopathic medicine statute.

Ms. DelGreco also provided an update on HB 867 - State Board of Physicians - Naturopathic Doctors - Prescriptive Authority and Administration of Medicine. She explained that the bill would repeal the Naturopathic Doctors Formulary Council, alter the prescriptive authority of

naturopathic doctors, and alter the methods by which a naturopathic doctor may administer medication.
