Revisions to Cosmetic Medical Procedures-Chemical Peels Regulations for Approval (10.32.09.02)

Board staff asked the Board to approve a proposed revision to the regulations to replace the definition of “Deep skin peels” with “Chemical peels that ablate living skin tissue”.
