Mr. Woodard stated that the regulations should be completed in approximately three months.

Ms. Van Horn informed the Committee that the Governor signed the Registered Cardiovascular Invasive Specialists (RCIS) legislation, House Bill 924 (Chapter 445). The law goes into effect October 1, 2019. Input is welcome as the Board drafts regulations addressing a licensed physician delegating duties to an RCIS assisting in the physician's performance of fluoroscopy under certain circumstances. Ms. Van Horn will present, at the next meeting, further information regarding the Board's development of draft regulations.
