**LEGISLATION, REGULATIONS, AND POLICY UPDATES**

**Status Update - House Bill 576 - Athletic Training - Revisions**

Ms. Hawk discussed the Athletic Trainer bill that passed during the 2020 legislative session. She stated HB 576 alters the definition of "practice athletic training"; defines "athletic individual"; repeals limitations on the settings in which athletic trainers may practice; repeals the requirement that an evaluation and treatment protocol describe the settings where the athletic trainer may practice; repeals obsolete language regarding the Athletic Trainer Advisory Committee; specifies that an athletic trainer may provide treatment for not more than 14 days to an athletic individual with an injury that affects job function or job-related activity except under specified circumstances; and makes technical changes.
