1. The removal of the requirement for a PA to inform the Board of every patient care team physician listed on a collaboration agreement at the time of execution;
2. The requirement to inform the Board of the addition or removal of a patient care team physician(s) from the collaboration agreement; and
3. The change from 10 days to 30 days to inform the Board of any change in name or address.
