Inquiry – Francesca Kirk, ATC

Ms. Francesca Kirk, a Maryland licensed athletic trainer, asked if she would be able to use an orthopedic technician certification with her athletic training license. The Committee and Board Counsel advised staff to reply to Ms. Kirk stating that the Board does not issue the orthopedic technician certification and therefore, cannot comment on the requirements and permitted scope of practice for this profession. They also advised staff to inform her that the athletic trainer license is separate and distinct from the orthopedic technician certification and that the athletic trainer license permits an individual to practice athletic training, as defined in Health Occupations Article 14-5D-01(p). In addition, employment as an orthopedic technician is separate from her practice as an athletic trainer.
