POLICY

FYI - First Draft - General Licensee and Initial Applicant Provisions Regulations For Discussion

Ms. DelGreco presented draft regulations, "General Licensee and Initial Applicant Provisions" and informed the Board that the draft regulations were preliminarily posted on the Board's website to solicit public comment. The Board reviewed the regulations and were advised to email or call Ms. DelGreco with any further comments.

FYI - Second Draft - COMAR 10.32.02 Hearings Before the Board of Physicians Proposed Regulations

Ms. Harris presented to the Board an FYI regarding the Second Draft of COMAR 10.32.02: Hearings Before the Board of Physicians proposed regulations. These revisions aim to modernize and clarify the Board's hearing procedures, ensure consistency with current practice and administrative law, and enhance clarity for licensees.

Ms. Harris reminded the Board of the regulations' timeline so far and how, at the September Panel B meeting, the Board approved the proposed regulations to proceed with the next step of the promulgation process.

Following the September board meeting, however, a single substantive change was added on page 40 to clarify the procedure for when a respondent does not request a hearing. Other changes were minor and non-substantive, involving reorganization, terminology updates, and alignment with current Board procedures. Following a second posting of the regulations for public comment, the Board received a few comments from an external attorney regarding certain revisions. The Board members were advised that staff and counsel are currently reviewing these comments and plan to address the concerns through response letters.

Ms. Harris, Ms. Rubin and Ms. Farrelly responded to question from Board members.

Policy Update: Internationally Trained Physicians

Mr. Tran informed the Board that staff had met with Delegate Terri Hill regarding her intentions to reintroduce the bill for internationally trained physicians. Mr. Tran specified that Delegate Hill clarified in the meeting that she envisions a phased implementation of a new licensure pathway for FTPs, starting with initially accepting applicants trained in certain countries, such as England and Canada, while continuing work to incorporate additional countries over time (applicants from most other nations would remain ineligible for licensure until further expansion occurs). The Board agreed that a decision or a vote could not occur without further details on how certain countries would be initially selected over others. Some Board members expressed concerns about potential

equity and discrimination issues with a phased approach, given the lack of a current accrediting body for the postgraduate medical training programs.

Dr. Ajrawat will contact Delegate Hill Directly and determine how best to proceed.
