A Board member from the Physician Assistant Advisory Committee suggested developing guidelines to qualify PA's for psychiatric advanced duties. After discussing, the Board decided to table the request and to revisit at its full Board meeting on October 31, 2018. Board staff also has requested that Dr. Smith attend.

Board staff also mentioned that the PA workgroup will meet in November to further discuss procedural issues.

*On a motion made by Dr. Roca, and seconded by Mr. Dills, the Board voted unanimously to **APPROVE** the addendum requests for Mr. Brennan Jr., PA-C, Ms. Schwartzbaum, PA-C, and Dr. Smith, to perform evaluations and basic pharmacologic treatment of patients with psychiatric disorders in a psychiatric setting and **TABLE** the request for advanced psychopharmacologic treatment and conduct diagnostic assessments psychopharm interventions and behavioral interventions to gather further information to discuss at the October 31, 2018 full Board meeting.*

*On a motion made by Dr. Rosenstein, and seconded by Mr. Dills, the Board voted unanimously to **APPROVE** all addendum requests to perform the aforementioned advanced duties following the recommendation of the Physician Assistant Advisory Committee, with the exception of the request for Mr. Brennan Jr., PA-C, Ms. Schwartzbaum, PA-C, and Dr. Smith. Dr. Boursiquot abstained from Ms. Wilkins/Dr. Kulshrestha request.*

Telehealth Regulations

1. Removed the requirement for telehealth practitioner's to provide their license number and location to patients.
2. Authorized the practitioner's to delegate the collecting and disseminating of patient information to other staff.

The Secretary's office agreed on the revised Telehealth regulations.
