**Maryland Board of Physicians
FY 2020 Annual Reporting Requirements**

Pursuant to the Health Occupations Article (H.O.), Md. Code Annotated, § §1-212, 14-205.1 and Chapters 612 and 613, Acts of 2020, information regarding the operations of the Board of Physicians (the “Board”) as outlined in items 1 through 15 below is provided as follows:

1. The number of new complaints¹ investigated for physicians, allied health practitioners, and unlicensed individuals:

- 864 complaints

2. The number of complaints that remain open as of June 30 of the immediately preceding fiscal year at the Board and at the Office of the Attorney General:

3. The three most common grounds for complaints:

- Disciplinary Ground §14-404(a)(3)(ii), is guilty of unprofessional conduct in the practice of medicine;
 - 398 allegations of unprofessional conduct in the practice of medicine.
- Disciplinary Ground §14-404(a)(22), fails to meet appropriate standards as determined by appropriate peer review of the delivery of quality medical and surgical care performed in an outpatient surgical facility, office, hospital, or any other location in this State;
 - 272 allegations of failure to meet the standard of care.
- Disciplinary Ground §14-404(a)(40), fails to keep adequate medical records as determined by appropriate peer review;
 - 82 allegations of failure to keep adequate medical records.

¹ All complaints received by the Board do not result in an investigation.

² The Annual Report is based on a 12-month fiscal year cycle; these cases are not over 18 months old.

15. State Board of Physicians and Allied Health Advisory Committees – Sunset Extension and Program Evaluation - Section 3 Reporting Requirement⁵:

On May 8, 2020, sunset legislation, titled “State Board of Physicians and Allied Health Advisory Committees – Sunset Extension and Program Evaluation,” went into effect. Section 3 of the sunset legislation requested that the Board study the combining of two allied health committees:

“AND BE IT FURTHER ENACTED, That, in the annual report the State Board of Physicians is required to submit under § 14–205.1 of the Health Occupations Article, as enacted by Section 1 of this Act, on or before October 1, 2021, the Board shall include:

(1) a description of the study conducted by the Board in consultation with the Polysomnography Professional Standards Committee and the Respiratory Care Professional Standards Committee on the powers and duties of the Polysomnography Professional Standards Committee; and

(2) make recommendations on whether to alter the duties of the Polysomnography Professional Standards Committee or combine the Polysomnography Professional Standards Committee with the Respiratory Care Professional Standards Committee or another allied health advisory committee.”

During the 2020 interim, the Respiratory Care Professional Standards Committee (RCPSC) and the Polysomnography Professional Standards Committee (PPSC) conducted the study at their scheduled meetings and made the following recommendations:

- There is a need for both committees based on members’ areas of expertise; the RCPSC cannot absorb the responsibilities of the PPSC;
- Collaboration would be beneficial for the committee members when overlapping issues arise; and
- The committees could hold at least one joint meeting per year on an as-needed basis.

During the Board open session on August 26, 2020, disciplinary panels A and B considered and agreed with the conclusions reached by the committee members. The recommendations will be implemented immediately, beginning at the next scheduled RCPSC and PPSC meetings.
