CHAIR'S CALL TO ORDER/REPORT

EXECUTIVE REPORT

Carole Catalfo, Executive Director, reported the following action items:

Per Diems- In order to more efficiently track payments for per diems, Board members were asked to complete one expense report each month.

DLS-The Board has made great progress in addressing recommendations of the Department of Legislative Services. The Board has completed about 35 of the 46 recommendations. MBP's legislative briefing for sanctioning guidelines will be held on January 30, 2013. Members were encouraged to call or email Ms. Catalfo if they had any questions.

Maryland Association of Naturopathic Physicians

Emily Telfair, ND, Dr. Stephany Porter, Dr. Kevin Passero, and colleagues from the Maryland Association of Naturopathic Medicine are seeking support from the Board on legislation establishing a Board of Naturopathic Medicine. The bill would provide for licensure and discipline of naturopathic physicians as independent practitioners in Maryland. The intent is to differentiate naturopaths who have been through accredited education programs and passed national exams from people with online training only, no clinical training, who may now call themselves naturopaths.
